 $\mathbf{2}$ (c)In ANNE ARUNDEL COUNTY AND MONTGOMERY COUNTY, IN 3 addition to all other information required by this section, the [Montgomery County Board of Education] COUNTY BOARD, on request of the [County Executive] COUNTY 4 **EXECUTIVE** and [County Council] **COUNTY COUNCIL**, shall provide with the annual $\mathbf{5}$ 6 budget the program implications of recommendations for reductions to or increases in $\overline{7}$ its annual budget, at whatever different levels of funding and accompanied by 8 whatever reasonable supporting detail and analysis, as may be specified by the 9 [County Executive] COUNTY EXECUTIVE and [County Council] COUNTY COUNCIL. 10 Prior to the submission of the annual budget, similar information shall be submitted by the [Superintendent of Schools] COUNTY SUPERINTENDENT upon request by the 11 [County Executive] COUNTY EXECUTIVE or [County Council] COUNTY COUNCIL. 12

(e) In addition to all other information required by this section, the Cecil
 County Board of Education, on request of the Cecil County Board of Estimates, AND
 THE ANNE ARUNDEL COUNTY BOARD OF EDUCATION, ON REQUEST OF THE
 COUNTY EXECUTIVE AND COUNTY COUNCIL, shall provide with the annual budget
 separate information on the number of and costs associated with school-based
 noninstructional personnel.

(f) (1) In ANNE ARUNDEL COUNTY AND PRINCE GEORGE'S COUNTY,
IN addition to all other information required by this section, the [Prince George's
County Board of Education] COUNTY BOARD shall provide to the [County Executive]
COUNTY EXECUTIVE and [County Council] COUNTY COUNCIL with the annual
budget, information relating to each of the following categories:

- 24(i) Instructional supplies and materials; 25(ii) Additional equipment; and 26Replacement equipment. (iii) 27For the categories specified in paragraph (1) of this subsection, the (2)following information shall be provided for the public school system in the county: 2829Proposed expenditures for the next school year based on the (i) 30 annual budget;
- 31 (ii) Estimated expenditures for the current school year; and
- 32 (iii) Actual expenditures for the prior school year.
