## A BILL ENTITLED

1 AN ACT concerning

2 **Creation of State Debt – Maryland Consolidated Capital Bond Loan of 2011,**  
3 **and the Maryland Consolidated Capital Bond Loans of 1996, 2003, 2004, 2005,**  
4 **2006, 2007, 2008, 2009, and 2010**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of Nine  
6 Hundred Thirty–Five Million, Six Hundred Eighteen Thousand (\$935,618,000),  
7 the proceeds to be used for certain necessary building, construction, demolition,  
8 planning, renovation, conversion, replacement, and capital equipment  
9 purchases of this State, for acquiring certain real estate in connection  
10 therewith, and for grants to certain subdivisions and other organizations for  
11 certain development and improvement purposes, subject to the requirement  
12 that certain grantees provide and expend certain matching funds by certain  
13 dates; providing generally for the issuance and sale of bonds evidencing the  
14 loan; authorizing the creation of State Debt to be issued in 2012, the proceeds to  
15 be used for certain purposes; authorizing the creation of State Debt to be issued  
16 in 2013, the proceeds to be used for certain purposes; authorizing the creation of  
17 State Debt to be issued in 2014, the proceeds to be used for certain purposes;  
18 imposing a certain tax on all assessable property in the State; requiring that  
19 certain grantees convey certain easements under certain circumstances to the  
20 Maryland Historical Trust; providing that the proceeds of certain loans must be  
21 expended or encumbered by a certain date; requiring certain grantees to submit  
22 certain reports; providing that certain authorizations do not terminate before a  
23 certain date; authorizing certain unexpended appropriations in certain prior  
24 capital budgets and bond loans to be expended for other public projects; altering  
25 certain requirements for certain projects and programs in certain prior capital  
26 budgets and bond loans; providing that the authorizations of State Debt in  
27 certain prior capital budgets and bond loans be reduced by certain amounts;  
28 providing for certain additional information to be detailed about each project in  
29 the capital program under certain circumstances; requiring that certain projects  
30 be constructed at certain locations; repealing certain requirements for certain  
31 appropriations; requiring the Comptroller to make certain transfers,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 13 MARYLAND, That:

14 (1) The Board of Public Works may borrow money and incur indebtedness on  
 15 behalf of the State of Maryland through a State loan to be known as the Maryland  
 16 Consolidated Capital Bond Loan of 2011 in the total principal amount of \$935,618,000.  
 17 This loan shall be evidenced by the issuance, sale, and delivery of State general  
 18 obligation bonds authorized by a resolution of the Board of Public Works and issued,  
 19 sold, and delivered in accordance with §§ 8–117 through 8–124 of the State Finance  
 20 and Procurement Article and Article 31, § 22 of the Code.

21 (2) The bonds to evidence this loan or installments of this loan may be sold  
 22 as a single issue of bonds under § 8–122 of the State Finance and Procurement Article.

23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer  
 24 and first shall be applied to the payment of the expenses of issuing, selling, and  
 25 delivering the bonds, unless funds for this purpose are otherwise provided, and then  
 26 shall be credited on the books of the Comptroller and expended, on approval by the  
 27 Board of Public Works, for the following public purposes, including any applicable
