13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That:

- 18 (3) ZA03 LOCAL SENATE INITIATIVES
- 19 (U) Roland Park Fire Station Rehabilitation. Provide a grant of 20\$110,000, to the [Baltimore City Fire Department] MAYOR 21AND CITY COUNCIL OF THE CITY OF BALTIMORE for the repair and renovation of the Roland Park Fire Station, located 2223in Baltimore City, subject to a requirement that the grantee 24provide and expend a matching fund of \$20,000. 25Notwithstanding Section 1(5) of this Act, the matching fund



1	may consist of in kind contributions or funds expended prior
2	to the effective date of this Act, AND THE GRANTEE HAS
3	UNTIL JUNE 1, 2013, TO PRESENT EVIDENCE THAT A
4	MATCHING FUND WILL BE PROVIDED.

9	JUNE 1, 2013 (Baltimore City)

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 June 1, 2011.
