- FOR the purpose of authorizing the State Board of Physical Therapy Examiners to send license renewal notices by electronic means; altering the maximum amount of a certain fine; altering certain definitions; and generally relating to the licensure and regulation of physical therapists and physical therapist assistants.

4 5	(a) (1) A license expires on the date set by the Board, unless the license is renewed for an additional term as provided in this section.
6	(2) A license may not be renewed for a term longer than 2 years.
7 8 9 10	(b) (1) [At] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, AT least 1 month before the license expires, the Board shall send to the licensee, by first—class mail to the last known address of the licensee, a renewal notice that states:
