SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article – Agriculture

11–204.6.

(a) (1) There is a “Weights and Measures Fund”.

(2) All fees collected under §§ 11–204.3, 11–204.4, and 11–204.7 of this subtitle shall be credited to the Fund.

(3) The Fund shall be used to defray the expenses of administering this title.

(b) (1) The Fund shall be used for the purposes stated in this title [and unspent portions of the Fund shall revert to the General Fund of the State].

(2) AT THE END OF A FISCAL YEAR, ANY UNSPENT OR UNENCUMBERED BALANCE IN THE FUND MAY NOT REVERT TO THE GENERAL FUND OF THE STATE, BUT SHALL REMAIN IN THE WEIGHTS AND MEASURES FUND.

~~(A) [The fees for registering each weight and measure used for commercial purposes under this subtitle are as follows.] THE SECRETARY SHALL ESTABLISH BY REGULATION AN APPROPRIATE FEE TO DEFRAY THE COSTS OF ADMINISTERING THIS TITLE FOR EACH OF THE FOLLOWING WEIGHTS AND MEASURES:~~
