- 3 FOR the purpose of authorizing the issuance of a certain number of additional winery 4 special event permits to certain wineries for use in certain farmers' markets in 5 Baltimore County; prohibiting a winery from using more than a certain number of winery special event permits at the same farmers' market in the county in a 6 7 year; prohibiting a holder of a permit from selling wine by the glass; requiring 8 that a certain individual who is certified by an alcohol awareness program be 9 present during the hours when wine may be sold; and generally relating to 10 farmers' markets in Baltimore County.
