A BILL ENTITLED AN ACT concerning 1 2 Election Law - Citizens Who Have Not Lived in the United States - Right to 3 Vote 4 FOR the purpose of providing that a citizen who has not lived in the United States but 5 has a parent who is a registered voter in the State is a resident of the State for 6 purposes of voter registration; prohibiting an individual from being considered a 7 resident of the State if the individual has established a domicile outside the 8 State; authorizing an individual to register to vote and vote in the county in the 9 State where a parent resides if the individual meets certain requirements; and generally relating to enfranchising certain citizens who have not lived in the 10 United States. 11 12 BY repealing and reenacting, with amendments, 13 Article – Election Law Section 3-102 14 Annotated Code of Maryland 15 (2010 Replacement Volume) 16 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 MARYLAND, That the Laws of Maryland read as follows: 19 Article - Election Law 20 3-102.21 Except as provided in subsection (b) of this section, an individual (a) (1) 22may become registered to vote if the individual: 23(i) is a citizen of the United States; 24is at least 16 years old; (ii)

1 2	(iii) is a resident of the State as of the day the individual seeks to register; and
3	(iv) registers pursuant to this title.
4 5	(2) Notwithstanding paragraph (1)(ii) of this subsection, an individual under the age of 18 years:
6 7 8	(i) may vote in a primary election in which candidates are nominated for a general or special election that will occur when the individual is at least 18 years old; and
9	(ii) may not vote in any other election.
10	(b) An individual is not qualified to be a registered voter if the individual:
11 12 13	(1) has been convicted of a felony and is actually serving a court—ordered sentence of imprisonment, including any term of parole or probation, for the conviction;
14 15 16 17	(2) is under guardianship for mental disability and a court of competent jurisdiction has specifically found by clear and convincing evidence that the individual cannot communicate, with or without accommodations, a desire to participate in the voting process; or
18	(3) has been convicted of buying or selling votes.
19 20 21 22 23	(C) (1) FOR PURPOSES OF VOTER REGISTRATION UNDER SUBSECTION (A)(1)(III) OF THIS SECTION, A RESIDENT OF THE STATE SHALL INCLUDE A CITIZEN OF THE UNITED STATES BORN ABROAD WHO HAS NEVER LIVED IN THE UNITED STATES BUT WHO HAS A PARENT WHO IS A REGISTERED VOTER IN THE STATE.
242526	(2) AN INDIVIDUAL MAY NOT BE CONSIDERED A RESIDENT OF THE STATE UNDER PARAGRAPH (1) OF THIS SUBSECTION IF THE INDIVIDUAL HAS ESTABLISHED A DOMICILE OUTSIDE THE STATE.
27 28 29 30	(3) AN INDIVIDUAL WHO IS CONSIDERED A RESIDENT OF THE STATE UNDER THIS SUBSECTION, IS NOT REGISTERED TO VOTE IN ANOTHER STATE, AND IS OTHERWISE QUALIFIED MAY REGISTER TO VOTE AND VOTE IN THE COUNTY IN THE STATE WHERE A PARENT RESIDES.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 32 $\,$ June 1, 2011.
