CHAPTER AN ACT concerning Prescription Drug Repository Program - Disposal of Prescription Drugs and **Medical Supplies** FOR the purpose of altering the purpose of the Prescription Drug Repository Program to include disposal of certain prescription drugs and medical supplies; altering the definition of "repository" to include a licensed pharmacy approved by the State Board of Pharmacy to dispose of certain prescription drugs and medical supplies; altering a certain requirement relating to disposal of prescription drugs and medical supplies by a repository; authorizing a pharmacy to accept prescription drugs and medical supplies taken to the pharmacy for disposal only under certain circumstances; prohibiting the Program from requiring a private entity to establish, operate, or fund a drop-off site or disposal program:

17 18 19	(a) On or before January 1, 2007, and in consideration of the recommendations of the Task Force on the Establishment of a Prescription Drug Repository Program, the Board shall adopt regulations governing the Program.
20	(b) The regulations shall include:
21 22	(1) Categories of drugs that a repository will not accept, including a statement as to why the drug is ineligible for donation;
23 24	(2) A standard form each donor must sign stating that the donor is the owner of the drugs and intends to voluntarily donate them to the Program;
25 26	(3) Requirements for designation of drop-off sites to accept donated prescription drugs and medical supplies under the Program;
27 28	(4) Requirements for designation of repositories to dispense OR DISPOSE OF donated prescription drugs and medical supplies under the Program;
29 30 31	(5) Standards and procedures for accepting, safely storing, dispensing, shipping, and [if necessary,] disposing of donated prescription drugs and medical supplies;

- 7 (b) Except as otherwise provided in this section, a pharmacy for which a 8 pharmacy permit has been issued under this title:
- 9 (19) May not allow an unauthorized individual to represent that the individual is a pharmacist or registered pharmacy technician; [and]
- 11 (20) Shall provide information regarding the process for resolving 12 incorrectly filled prescriptions in accordance with existing regulations by:
- 13 (i) Posting a sign that is conspicuously positioned and readable 14 by consumers at the point where prescription drugs are dispensed to consumers; or
- 15 (ii) Including written information regarding the process with 16 each prescription dispensed; AND
