A BILL ENTITLED

1 AN ACT concerning

2 **Carroll County – Local Government Tort Claims Act – Industrial**
3 **Development Authority**

4 FOR the purpose of altering the definition of “local government” under the Local
5 Government Tort Claims Act to include the Industrial Development Authority
6 of Carroll County; and generally relating to the inclusion of the Industrial
7 Development Authority of Carroll County under the Local Government Tort
8 Claims Act.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article – Courts and Judicial Proceedings**

22 5–301.

23 (a) In this subtitle the following words have the meanings indicated.

- 6 (5) A municipal corporation established or operating under Article 23A
7 of the Code;
- 8 (6) The Maryland–National Capital Park and Planning Commission;
- 9 (7) The Washington Suburban Sanitary Commission;
- 10 (8) The Northeast Maryland Waste Disposal Authority;
- 11 (9) A community college or board of trustees for a community college
12 established or operating under Title 16 of the Education Article, not including
13 Baltimore City Community College;
- 14 (10) A county public library or board of trustees of a county public
15 library established or operating under Title 23, Subtitle 4 of the Education Article;
- 16 (11) The Enoch Pratt Free Library or Board of Trustees of the Enoch
17 Pratt Free Library;
- 18 (12) The Washington County Free Library or the Board of Trustees of
19 the Washington County Free Library;
- 20 (13) A special taxing district;
- 21 (14) A nonprofit community service corporation incorporated under
22 State law that is authorized to collect charges or assessments;
- 23 (15) Housing authorities created under Division II of the Housing and
24 Community Development Article;
- 25 (16) A sanitary district, sanitary commission, metropolitan commission,
26 or other sewer or water authority established or operating under public local law or
27 public general law;
- 28 (17) The Baltimore Metropolitan Council;
- 29 (18) The Howard County Economic Development Authority;

- 1 (19) The Howard County Mental Health Authority;
- 2 (20) A commercial district management authority established by a
3 county or municipal corporation if provided under local law;
- 4 (21) The Baltimore City Police Department;
- 5 (22) A regional library resource center or a cooperative library
6 corporation established under Title 23, Subtitle 2 of the Education Article;
- 7 (23) Lexington Market, Inc., in Baltimore City;
- 8 (24) The Baltimore Public Markets Corporation, in Baltimore City;
- 9 (25) The nonprofit corporation serving as the local public transportation
10 authority for Carroll County pursuant to a contract or memorandum of understanding
11 with Carroll County (Carroll County Senior Overland Service, Inc., t/a Carroll Area
12 Transit System);
- 13 (26) The nonprofit corporation serving as the animal control and
14 licensing authority for Carroll County pursuant to a contract or memorandum of
15 understanding with Carroll County (the Humane Society of Carroll County, Inc.);
- 16 (27) Garrett County Municipalities, Inc., in Garrett County; [and]
- 17 (28) The nonprofit corporation serving as the local public transportation
18 authority for Garrett County pursuant to a contract or memorandum of understanding
19 with Garrett County (Garrett County Community Action Committee, Inc.); AND
- 20 **(29) THE INDUSTRIAL DEVELOPMENT AUTHORITY OF CARROLL**
21 **COUNTY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 July 1, 2011.
