A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Statewide – Therapeutic**
3 **Pool for People with Disabilities**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009
5 to extend the deadline for the Board of Directors of The League for People with
6 Disabilities, Inc. to present evidence that a matching fund will be provided;
7 requiring that the Board of Public Works expend or encumber the proceeds of
8 the loan by June 1, 2013; and generally relating to amending the Maryland
9 Consolidated Capital Bond Loan of 2009.

10 BY repealing and reenacting, with amendments,
11 Chapter 485 of the Acts of the General Assembly of 2009
12 Section 1(3) Item ZA02(I) and Item ZA03(H)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

23 construction, repair, renovation, reconstruction, and capital
24 equipping of the Accessible Therapeutic Pool for The League
25 for People with Disabilities, located in Baltimore City.
