8	make certain recommendations; requiring the Task Force to report certain

11	relating to the Task Force to Study Manufactured Housing.		
12	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF		
13	MARYLAND, That:		
14	(a) There is a Task Force to Study Manufactured Housing.		
15	(b) The Task Force consists of the following members:		
16	(1) two members of the Senate of Maryland, appointed by the		
17	President of the Senate;		
18	(2) two members of the House of Delegates, appointed by the Speaker		
19	of the House;		
20	(3) one representative from the Motor Vehicle Administration,		
21	appointed by the Motor Vehicle Administrator;

1 (4) necessary changes to State law relating to the conversion of 2 manufactured homes to real property, the conveyance and lien perfection of 3 manufactured homes as real property, and the severance of manufactured homes from 4 real property, including changes to the definitions of "mobile home", "manufactured 5 home", "residential real property", "secondary mortgage loan", "goods", and 6 "residential real estate".

(h) On or before December 31, 2011, the Task Force shall report its findings
and recommendations to the Governor and, in accordance with § 2–1246 of the State
Government Article, the General Assembly.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2011. It shall remain effective for a period of 1 year and, at the end of 12 September 30, 2012, with no further action required by the General Assembly, this Act 13 shall be abrogated and of no further force and effect.
