Real Property - Condominium - Rescission of Sales Contracts

- FOR the purpose of limiting a condominium purchaser's right to rescind in writing a contract of sale based on amended material in a vendor's public offering statement to certain amendments that affect materially and adversely the purchaser's rights; requiring a purchaser to state in writing the purchaser's reason for rescission when it is based on certain amended material in a vendor's public offering statement; stating the intent of the General Assembly; making stylistic changes; and generally relating to the rescission of condominium sales contracts.

1 2	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

5 6	(a) A contract for the initial sale of a unit to a member of the public is not enforceable by the vendor unless:
7 8 9 10	(1) The purchaser is given on or before the time a contract is entered into between the vendor and the purchaser, a current public offering statement as amended and registered with the Secretary of State containing all of the information set forth in subsection (b) of this section; and
11	(2) The contract of sale contains, in conspicuous type, a notice of:
12 13	(i) The purchaser's right to receive a public offering statement and his rescission rights under this section; and
14	(ii) The warranties provided by § 11–131 of this title.
15 16	(b) The public offering statement required by subsection (a) of this section shall be sufficient for the purposes of this section if it contains at least the following:
17	(1) A copy of the proposed contract of sale for the unit;
18 19	(2) A copy of the proposed declaration, bylaws, and rules and regulations;
20 21	(3) A copy of the proposed articles of incorporation of the council of unit owners, if it is to be incorporated;

28 29 30	(5) A copy of the actual annual operating budget for the condominium or, if no actual operating budget exists, a copy of the projected annual operating budget for the condominium including reasonable details concerning:

8 9 10	(6) A plain language statement of the policy and procedures for collecting assessments and handling collection of delinquencies, including reasonable details concerning:
11 12 13	(i) The number and percentage of unit owners who are delinquent or in arrears in an amount equal to or greater than 50% of the annual assessment of the unit owner;
14 15	(ii) The number of unsatisfied liens currently recorded against unit owners under the Maryland Contract Lien Act;
16 17	(iii) The number of unsatisfied judgments obtained against unit owners for unpaid assessments; and
18	(iv) The total amount of arrearages among all unit owners;
19 20	(7) A copy of any lease to which it is anticipated the unit owners or the council of unit owners will be a party following closing;
21 22 23	(8) A description of any contemplated expansion of the condominium with a general description of each stage of expansion and the maximum number of units that can be added to the condominium;
24 25	(9) A copy of the floor plan of the unit or the proposed condominium plats;
26 27 28	(10) A description of any recreational or other facilities which are to be used by the unit owners or maintained by them or by the council of unit owners, and a statement as to whether or not they are to be part of the common elements;
29 30	(11) A statement as to whether streets within the condominium are to be dedicated to public use or maintained by the council of unit owners;
31 32	(12) A statement of any judgments against the council of unit owners and the existence of any pending suits to which the council of unit owners is a party;

- (13) In the case of a condominium containing buildings substantially completed more than 5 years prior to the filing of the application for registration under § 11–127 of this title, a statement of the physical condition and state of repair of the major structural, mechanical, electrical, and plumbing components of the improvements, to the extent reasonably ascertainable, and estimated costs of repairs for which a present need is disclosed in the statement and a statement of repairs which the vendor intends to make. The vendor is entitled to rely on the reports of architects or engineers authorized to practice their profession in this State;
- (14) A description of any provision in the declaration or bylaws limiting or providing for the duration of developer control or requiring the phasing—in of unit owner participation, or a statement that there is no such provision;
- 12 (15) If the condominium is one which will be created by the conversion 13 of a rental facility, a copy of the notice and materials required by §§ 11–102.1 and 14 11–137 of this title;
- 15 (16) A statement of whether the unit being purchased is subject to an extended lease under § 11–137 of this title, or local law, and a copy of any extended lease;
- 18 (17) A written notice of the unit owner's responsibility for the council of unit owners' property insurance deductible and the amount of the deductible; and
- 20 (18) Any other information required by regulation duly adopted and 21 issued by the Secretary of State.
 - (d) (1) Following execution of a contract of sale by a purchaser, the vendor may not amend any of the material required to be furnished by subsection (a) of this section without the approval of the purchaser if the amendment would affect materially the rights of the purchaser.
 - (2) Approval is not required if the amendment is required by any governmental authority or public utility, or if the amendment is made as a result of actions beyond the control of the vendor or in the ordinary course of affairs of the council of unit owners.
- 30 (3) A copy of any amendments shall be delivered promptly to any 31 purchaser and to the Secretary of State.
 - (e) (1) Any purchaser may RESCIND IN WRITING THE CONTRACT OF SALE, WITHOUT ANY LIABILITY ON THE PURCHASER'S PART, at any time [(1)] within:

22 23 24	(b) clarify that the right of a condominium unit purchaser to rescind a contract of sale when there is a change to the public offering statement only applies if the change materially and adversely affects the rights of the purchaser.
