# A BILL ENTITLED

### AN ACT concerning 1

### $\mathbf{2}$ Public Schools - Substitute Teachers - Qualifications, Training, and Study

- 3 FOR the purpose of requiring each county board of education to establish certain 4 qualifications for substitute teachers employed by a county board; requiring a  $\mathbf{5}$ county board to require each substitute teacher to complete a certain 6 orientation and training program; requiring county boards to train certain 7 school administrators in certain issues related to substitute teachers; requiring 8 a county superintendent to develop a certain in-service training program; requiring the State Department of Education to commission a certain study 9 10 regarding substitute teaching in the State; requiring the study to include 11 certain data; requiring the Department to submit a certain report to certain 12committees of the General Assembly on or before a certain date; and generally 13 relating to qualifications, training, and a study of substitute teachers in public schools. 14

AND BE IT FURTHER ENACTED, That: 8 The State Department of Education shall commission an (a) (1)9 independent study on the prevalence and effectiveness of substitute teaching in the 10 State. 11 (2)The study conducted under paragraph (1) of this subsection shall include the following data from each local jurisdiction: 1213demand for substitute teachers; (i) 14(ii) substitute teacher qualifications; 15(iii) existing orientation and training programs for substitute 16 teachers: 17number of and types of complaints filed against substitute (iv) 18 teachers: and 19 (v) percentage of time students are being instructed by 20substitute teachers. 21On or before June 30, 2012, the State Department of Education shall (b)22submit a report of its findings of the study conducted under this section, in accordance 23with § 2–1246 of the State Government Article, to the Senate Education, Health, and 24Environmental Affairs Committee and the House Committee on Ways and Means.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 July 1, 2011.
