#### 1 AN ACT concerning

#### 2 Business Regulation – Retail Pet Stores – Required Records for Dogs

- 3 FOR the purpose of requiring a retail pet store that sells dogs to post conspicuously on 4 each dog's cage certain information about the dog; requiring a retail pet store to  $\mathbf{5}$ maintain a written record which contains certain information about each dog in 6 the possession of the retail pet store; requiring a retail pet store to maintain a 7 certain record for a certain period of time after the date of sale of a dog; 8 requiring a retail pet store to make certain records available for inspection by 9 the Department of Labor, Licensing, and Regulation under certain circumstances; defining a certain term; and generally relating to required 10 records for retail pet stores. 11

THE LITTER NUMBER; AND 6 (3) FOR EACH DOG ACQUIRED BY THE RETAIL PET STORE, 7MAINTAIN A WRITTEN RECORD OF THE HEALTH, STATUS, AND DISPOSITION OF 8 THE DOG, INCLUDING ANY DOCUMENTS THAT ARE REQUIRED AT THE TIME OF 9 SALE. 10 A RETAIL PET STORE SHALL MAINTAIN A COPY OF THE RECORDS **(C)** 11 **REQUIRED UNDER SUBSECTION (B) OF THIS SECTION FOR AT LEAST 1 YEAR** AFTER THE DATE OF SALE OF THE DOG. 1213**(D)** ON REASONABLE NOTICE FROM THE DEPARTMENT, A RETAIL PET 14STORE SHALL MAKE THE RECORDS REQUIRED UNDER SUBSECTION (B) OF THIS SECTION AVAILABLE FOR INSPECTION BY THE DEPARTMENT. 1516 SECTION 2.
