2 Rental Housing – Tenant Victim of Domestic Violence or Sexual Assault – 3 Lease Payment Obligation

- FOR the purpose of altering the liability under a residential lease if a tenant victim of 4 domestic violence or sexual assault terminates the lease and vacates the 5 6 premises; authorizing the tenant victim to terminate future liability under the 7 lease except for a certain period of time after providing notice of an intent to 8 vacate; establishing that this Act does not terminate or in any way impact the 9 liability under the residential lease for the tenant who is the respondent in a 10 certain cause of action resulting in a protective order or peace order for the 11 victim tenant or victim legal occupant; making a clarifying change; and generally relating to the lease payment obligation of a tenant victim of domestic 12 13 violence or sexual assault.

- 2 (a) Subject to the requirements of [subsection (b)] SUBSECTIONS (B) AND 3 (C) of this section, a tenant may terminate THE TENANT'S FUTURE LIABILITY UNDER a residential lease if the tenant or legal occupant is:
- 5 (1) A victim of domestic violence; or
- 6 (2) A victim of sexual assault.
- 7 (b) If a tenant or legal occupant is a victim of domestic violence or a victim of 8 sexual assault, the tenant may provide to the landlord the written notice required 9 under § 8–5A–03 or § 8–5A–04 of this subtitle and, if the written notice is provided, 10 the tenant shall have 30 days to vacate the leased premises from the date of providing 11 the written notice.
- 12 (c) A tenant who vacates leased premises under this section is responsible 13 for rent **ONLY** for the 30 days following the tenant providing notice of an intent to 14 vacate.
- 15 (d) If a tenant does not vacate the leased premises within 30 days of providing to the landlord the written notice required under § 8–5A–03 or § 8–5A–04 of this subtitle, the landlord is, at the landlord's option and with written notice to the tenant, entitled to:
- 19 (1) All legal remedies against a tenant holding over available under \S 20 8–402 of this title; or
- 21 (2) Deem the tenant's notice of an intent to vacate to have been 22 rescinded and the terms of the original lease to be in full force and effect.
