4 FOR the purpose of exempting certain alcoholic beverages businesses in Wicomico 5 County from a certain prohibition against having a financial interest in a 6 premises where alcoholic beverages are sold at retail or in any other business 7 conducted by an alcoholic beverages licensee; altering the number of Class B 8 beer, wine and liquor licenses that a person may hold and still remain eligible to 9 be issued a pub-brewery or micro-brewery license; authorizing a holder of a certain license to be eligible to be issued a micro-brewery license and certain 10 other licenses; and generally relating to alcoholic beverages in Wicomico 11 12 County.

(5)(i) 13 (ii) Subject to subparagraph (iii) of this paragraph, the 14 Comptroller may issue one Class 6 pub-brewery license or one Class 7 micro-brewery 15 license, but not both, to a person that holds not more than [three] FIVE Class B beer, wine and liquor licenses. 16 17 A Class 6 pub-brewery license or a Class 7 micro-brewery (iii) license issued under subparagraph (ii) of this paragraph may be issued only for a 18 19 location in an enterprise zone. 20 (IV) A HOLDER OF A CLASS A LICENSE MAY ALSO HOLD A 21CLASS 7 MICRO-BREWERY LICENSE AND NOT MORE THAN FIVE CLASS B BEER, 22 WINE AND LIQUOR LICENSES UNDER THIS PARAGRAPH. 23 SECTION 2.
