1 AN ACT concerning

## 2 State Board of Podiatric Medical Examiners - Volunteer Podiatrist License

3 FOR the purpose of authorizing the State Board of Podiatric Medical Examiners to 4 convert certain licenses to volunteer podiatrist licenses and issue volunteer 5 podiatrist licenses to certain individuals if certain requirements are met; 6 requiring that a certain application form include a certain certification by the 7 applicant; requiring that the fees charged by the Board for a volunteer 8 podiatrist license be set lower than the fees charged for licensure to practice 9 podiatry; requiring that a volunteer podiatrist license be clearly designated as a 10 volunteer podiatrist license; authorizing the Board to revoke the license of a 11 volunteer podiatrist under certain circumstances; altering certain definitions; and generally relating to volunteer podiatrist licenses issued by the State Board 12 of Podiatric Medical Examiners. 13

- professional school is acceptable as proof of proficiency in the oral communication of the English language under this section.
- 3 (3) By regulation, the Board shall develop a procedure for testing 4 individuals who because of their speech impairment are unable to complete 5 satisfactorily a Board approved standardized test of oral competency.
  - (4) If any disciplinary charges or action that involves a problem with the oral communication of the English language are brought against a licensee under this title, the Board shall require the licensee to take and pass a Board approved standardized test of oral competency.

- 11 (a) The Board shall issue a license to any applicant who, by the affirmative 12 vote of a majority of the full authorized membership of the Board, meets the 13 requirements of this title.
- 14 (b) The Board shall include on each license that the Board issues:
- 15 (1) The signature of the Secretary of the Department of Health and 16 Mental Hygiene attesting that the individual meets the requirements of this title; and
- 17 (2) A serial number that corresponds to an entry in the registration 18 records of the Board.
