$\frac{18}{19}$	(a) (1) This section does not apply to the laws that relate to the sale of alcoholic beverages.
20	(2) This section does not apply in Wicomico County.

- 1 (c) Notwithstanding an agreement to the contrary between a merchant and 2 landlord:
- 3 (1) the landlord may not directly or indirectly require the merchant to 4 open the merchant's place of business on Sunday; and
- 5 (2) a landlord may not directly or indirectly cancel or refuse to renew 6 the merchant's lease because the merchant refuses to open the merchant's place of 7 business on Sunday.

8 (d) Except in Howard, Montgomery, and Prince George's counties, and except 9 as provided in [subsection (g)] **SUBSECTIONS (G)** AND (H) of this section, a new or 10 used car dealer may not sell, barter, deliver, give away, show, or offer for sale a motor 11 vehicle or certificate of title for a motor vehicle on Sunday.

12 (e) In Anne Arundel County, a dealer may sell, barter, deliver, give away, 13 show, or offer for sale on Sunday a new or used camping trailer, mobile home, or travel 14 trailer, as those terms are defined in Title 11 of the Transportation Article.

15 (f) A new or used car dealer who violates subsection (d) of this section is 16 guilty of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.

(g) In Anne Arundel County and Worcester County, a dealer may sell, barter,
deliver, give away, show, or offer for sale a motorcycle, as defined in § 11–136 of the
Transportation Article, or certificate of title for a motorcycle on Sunday.

(H) IN BALTIMORE CITY, A USED CAR DEALER MAY SELL, BARTER,
DELIVER, GIVE AWAY, SHOW, OR OFFER FOR SALE A MOTOR VEHICLE OR
CERTIFICATE OF TITLE FOR A MOTOR VEHICLE ON SUNDAY, INSTEAD OF
SATURDAY, IF THE DEALER NOTIFIES THE MOTOR VEHICLE ADMINISTRATION
IN ADVANCE THAT THE DEALER INTENDS TO CONDUCT BUSINESS ON SUNDAY,
INSTEAD OF SATURDAY.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 2011.
