## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Public Safety – Law Enforcement Officers’ Bill of Rights – Internal**  
3 **Investigation Unit**

4 FOR the purpose of including the Internal Investigation Unit of the Department of  
5 Public Safety and Correctional Services in the definition of law enforcement  
6 officer covered by the Law Enforcement Officers’ Bill of Rights.

7 BY repealing and reenacting, with amendments,  
8 Article – Public Safety  
9 Section 3–101(e)  
10 Annotated Code of Maryland  
11 (2003 Volume and 2010 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 3–101.

16 (e) (1) “Law enforcement officer” means an individual who:

17 (i) in an official capacity is authorized by law to make arrests;

  - 12 Commissioner of Baltimore City;
  - 13                                    (ii)    an individual who serves at the pleasure of the appointing
  - 14 authority of a charter county;
  - 15                                    (iii)    the police chief of a municipal corporation;
  - 16                                    (iv)    an officer who is in probationary status on initial entry into
  - 17 the law enforcement agency except if an allegation of brutality in the execution of the
  - 18 officer’s duties is made;
  - 19                                    (v)    a Montgomery County fire and explosive investigator as
  - 20 defined in § 2–208.1 of the Criminal Procedure Article;
  - 21                                    (vi)    an Anne Arundel County or City of Annapolis fire and
  - 22 explosive investigator as defined in § 2–208.2 of the Criminal Procedure Article;
