BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – Transportation** 2-606.The Governor shall appoint a Bicycle and Pedestrian Advisory Committee (a) to provide guidance to State agencies concerning: Funding of bicycle and pedestrian related programs; (1)

9 10	(2) The terms of members are staggered as required by the terms provided for members of the Committee on October 1, 2001.
11 12	(3) At the end of a term, a member continues to serve until a successor is appointed and qualifies.
13 14	(4) A member who is appointed after a term has begun serves only for the rest of the term and until a successor is appointed and qualifies.
15 16	(g) The Committee may adopt procedures necessary to ensure the orderly transaction of business.
17 18	(h) The Committee shall [meet at least quarterly with at least one meeting held in Annapolis] HOLD REGULAR MEETINGS AS IT DEEMS APPROPRIATE.
19 20 21	(i) A member of the Committee may not receive compensation but shall be reimbursed for expenses under the Standard State Travel Regulations, as provided for in the State budget.
22 23	(j) The Department shall provide staff, administrative support, and operating expenses for the Committee as provided in the State budget.
