A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Seizure and Forfeiture – Property Used in Human**
3 **Trafficking**

4 FOR the purpose of authorizing a State or local law enforcement agency, on process
5 issued by a court of competent jurisdiction, to seize certain property used or
6 intended for use in connection with a violation of the law prohibiting human
7 trafficking; including in the prohibition against human trafficking a prohibition
8 against subjecting a person to involuntary servitude, peonage, debt bondage, or
9 slavery under certain circumstances; creating an Anti-Human Trafficking Fund
10 to be administered by the Executive Director of the Governor's Office of Crime
11 Control and Prevention; specifying the revenue sources for the Fund; providing
12 for certain disbursements from the Fund for certain purposes; specifying certain
13 property subject to forfeiture; specifying certain conditions to exclude property
14 from forfeiture; authorizing the seizure of certain property with or without a
15 warrant under certain circumstances; requiring the seizing authority that
16 seizes money to take certain actions; specifying certain standards and
17 exceptions regarding the seizure of motor vehicles; requiring a certain law
18 enforcement officer to recommend that a motor vehicle be forfeited under
19 certain circumstances; requiring that a forfeiting authority surrender a motor
20 vehicle on request to the owner under certain circumstances; specifying
21 conditions under which an owner may obtain possession of seized property;
22 specifying the time when seizure of real property occurs; authorizing an owner
23 or owner's tenant to remain in possession of seized real property under certain
24 circumstances; prohibiting an owner of real property from taking certain
25 actions; specifying certain procedures for the conduct of forfeiture proceedings,
26 including the filing of complaints and answers, posting and publishing of notice,
27 and conducting hearings for real property and other property; specifying certain
28 restrictions on forfeiture proceedings on property used as the principal family
29 residence; specifying certain powers of a court in a certain forfeiture proceeding;
30 requiring a court to issue a certain order after a full hearing under certain

circumstances; authorizing the governing body where the property was seized to take certain actions; requiring certain proceeds to be used for certain expenses; requiring that certain proceeds of the sale of forfeited property be distributed to the Fund for a certain purpose; specifying the terms of sale of forfeited property; specifying the law governing the sale of certain collateral; requiring certain proceeds from the sale of certain property to be distributed in a certain manner; requiring lienholders to take certain actions before exercising the right to sell certain property and after the redemption of certain property; specifying the effect of this Act; defining certain terms; providing for the application of this Act; and generally relating to seizure and forfeiture of property used in connection with a violation of the human trafficking law.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
MARYLAND, That the Laws of Maryland read as follows:

Article – Criminal Law

11–303.

(a) (1) A person may not knowingly:

(i) take or cause another to be taken to any place for
prostitution;

(ii) place, cause to be placed, or harbor another in any place for
prostitution;

(iii) persuade, induce, entice, or encourage another to be taken to
or placed in any place for prostitution;

(iv) receive consideration to procure for or place in a house of prostitution or elsewhere another with the intent of causing the other to engage in prostitution or assignation;

(v) engage in a device, scheme, or continuing course of conduct intended to cause another to believe that if the other did not take part in a sexually explicit performance, the other or a third person would suffer physical restraint or serious physical harm; [or]

(vi) destroy, conceal, remove, confiscate, or possess an actual or purported passport, immigration document, or government identification document of another while otherwise violating or attempting to violate this subsection; **OR**

(VII) 1. RECRUIT, HARBOR, TRANSPORT, PROVIDE, OR OBTAIN A PERSON FOR LABOR OR SERVICES; AND

2. THROUGH FORCE, FRAUD, OR COERCION, SUBJECT THE PERSON TO INVOLUNTARY SERVITUDE OR DEBT BONDAGE.

(2) A parent, guardian, or person who has permanent or temporary care or custody or responsibility for supervision of another may not consent to the taking or detention of the other for prostitution.

(b) (1) A person may not violate subsection (a) of this section involving a victim who is a minor.

(2) A person may not knowingly take or detain another with the intent to use force, threat, coercion, or fraud to compel the other to marry the person or a third person or perform a sexual act, sexual contact, or vaginal intercourse.

(c) (1) (i) Except as provided in paragraph (2) of this subsection, a person who violates subsection (a) of this section is guilty of the misdemeanor of human trafficking and on conviction is subject to imprisonment not exceeding 10 years or a fine not exceeding \$5,000 or both.

(ii) A person who violates subsection (a) of this section is subject to § 5–106(b) of the Courts Article.

(2) A person who violates subsection (b) of this section is guilty of the felony of human trafficking and on conviction is subject to imprisonment not exceeding 25 years or a fine not exceeding \$15,000 or both.

(d) A person who violates this section may be charged, tried, and sentenced in any county in or through which the person transported or attempted to transport the other.

(e) (1) A person who knowingly benefits financially or by receiving anything of value from participation in a venture that includes an act described in subsection (a) or (b) of this section is subject to the same penalties that would apply if the person had violated that subsection.

(2) A person who knowingly aids, abets, or conspires with one or more other persons to violate any subsection of this section is subject to the same penalties that apply for a violation of that subsection.

(d) “Executive Director” means the Executive Director of the Governor’s Office of Crime Control and Prevention.

11–920.

(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) “FUND” MEANS THE ANTI–HUMAN TRAFFICKING FUND.

(3) “HUMAN TRAFFICKING” MEANS ANY VIOLATION OF § 11–303 OF THE CRIMINAL LAW ARTICLE.

(B) THERE IS AN ANTI–HUMAN TRAFFICKING FUND.

(C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR:

(1) AID FOR VICTIMS OF HUMAN TRAFFICKING; AND

(2) FUNDING FOR LAW ENFORCEMENT, NONPROFIT, AND PRIVATE ORGANIZATIONS THAT ENGAGE IN ACTIVITIES TO COMBAT HUMAN TRAFFICKING.

(D) THE EXECUTIVE DIRECTOR SHALL ADMINISTER THE FUND.

(E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

(2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

(F) THE FUND CONSISTS OF:

(1) REVENUE DISTRIBUTED TO THE FUND UNDER § 13-509 OF THIS ARTICLE;

(2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND; AND

(3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR THE BENEFIT OF THE FUND.

(G) (1) AT LEAST 50% OF THE MONEY IN THE FUND SHALL BE GIVEN TO NONPROFIT OR PRIVATE ORGANIZATIONS THAT:

(I) PROVIDE DIRECT SERVICES TO VICTIMS OF HUMAN TRAFFICKING;

(II) CONDUCT PROGRAMS FOR THE PREVENTION OF HUMAN TRAFFICKING; OR

(III) CONDUCT EDUCATION, TRAINING, OR PUBLIC OUTREACH PROGRAMS ABOUT HUMAN TRAFFICKING.

(2) AFTER THE DISTRIBUTION UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE BALANCE OF THE MONEY IN THE FUND SHALL BE USED FOR THE PURPOSES SPECIFIED IN PARAGRAPH (1) OF THIS SUBSECTION AND TO PROVIDE FUNDING FOR LAW ENFORCEMENT ORGANIZATIONS THAT RESPOND TO AND INVESTIGATE HUMAN TRAFFICKING VIOLATIONS.

(H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

(2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED TO THE GENERAL FUND OF THE STATE.

(I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE WITH THE STATE BUDGET.

(J) MONEY EXPENDED FROM THE FUND FOR VICTIMS OF HUMAN TRAFFICKING AND TO FINANCE ACTIVITIES THAT COMBAT HUMAN TRAFFICKING IS SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE APPROPRIATED FOR VICTIMS OF HUMAN TRAFFICKING OR ACTIVITIES THAT COMBAT HUMAN TRAFFICKING.

1 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**
2 **INDICATED.**

3 **(B) “CHIEF EXECUTIVE OFFICER” MEANS:**

4 **(1) FOR BALTIMORE CITY, THE MAYOR;**

5 **(2) FOR A CHARTER COUNTY, THE COUNTY EXECUTIVE OR, IF**
6 **THERE IS NO COUNTY EXECUTIVE, THE COUNTY COUNCIL;**

7 **(3) FOR A CODE COUNTY, THE COUNTY COMMISSIONERS OR**
8 **COUNTY COUNCIL;**

9 **(4) FOR A COUNTY COMMISSIONER COUNTY, THE COUNTY**
10 **COMMISSIONERS; OR**

11 **(5) FOR A MUNICIPAL CORPORATION, THE LEGISLATIVE BODY**
12 **ESTABLISHED BY MUNICIPAL CHARTER.**

13 **(C) “CONVICTED” MEANS FOUND GUILTY.**

14 **(D) “FINAL DISPOSITION” MEANS A DISMISSAL, ENTRY OF A NOLLE**
15 **PROSEQUI, THE MARKING OF A CRIMINAL CHARGE “STET” ON THE DOCKET,**
16 **ENTRY OF A NOT GUILTY VERDICT, THE PRONOUNCEMENT OF SENTENCE, OR**
17 **IMPOSITION OF PROBATION UNDER § 6–220 OF THIS ARTICLE.**

18 **(E) “FORFEITING AUTHORITY” MEANS:**

19 **(1) THE UNIT OR PERSON DESIGNATED BY AGREEMENT BETWEEN**
20 **THE STATE’S ATTORNEY FOR A COUNTY AND THE CHIEF EXECUTIVE OFFICER**
21 **OF THE GOVERNING BODY HAVING JURISDICTION OVER ASSETS SUBJECT TO**
22 **FORFEITURE TO ACT ON BEHALF OF THE GOVERNING BODY REGARDING THOSE**
23 **ASSETS; OR**

24 **(2) IF THE SEIZING AUTHORITY IS A UNIT OF THE STATE, A UNIT**
25 **OR PERSON THAT THE ATTORNEY GENERAL OR THE ATTORNEY GENERAL’S**
26 **DESIGNEE DESIGNATES BY AGREEMENT WITH A STATE’S ATTORNEY, COUNTY**
27 **ATTORNEY, OR MUNICIPAL ATTORNEY TO ACT ON BEHALF OF THE STATE**
28 **REGARDING ASSETS SUBJECT TO FORFEITURE BY THE STATE.**

29 **(F) “GOVERNING BODY” INCLUDES:**

30 **(1) THE STATE, IF THE SEIZING AUTHORITY IS A UNIT OF THE**
31 **STATE;**

1 (2) A COUNTY, IF THE SEIZING AUTHORITY IS A UNIT OF A
2 COUNTY;

3 (3) A MUNICIPAL CORPORATION, IF THE SEIZING AUTHORITY IS A
4 UNIT OF A MUNICIPALITY; AND

5 (4) BALTIMORE CITY, IF THE SEIZING AUTHORITY IS THE
6 BALTIMORE POLICE DEPARTMENT.

7 (G) “HUMAN TRAFFICKING LAW” MEANS § 11-303 OF THE CRIMINAL
8 LAW ARTICLE.

9 (H) “LIEN” INCLUDES A MORTGAGE, DEED OF TRUST, PLEDGE,
10 SECURITY INTEREST, ENCUMBRANCE, OR RIGHT OF SETOFF.

11 (I) “LIENHOLDER” MEANS A PERSON WHO HAS A LIEN OR A SECURED
12 INTEREST ON PROPERTY CREATED BEFORE THE SEIZURE.

13 (J) “LOCAL FINANCIAL AUTHORITY” MEANS:

14 (1) IF THE SEIZING AUTHORITY IS A UNIT OF A COUNTY, THE
15 TREASURER OR DIRECTOR OF FINANCE OF THE COUNTY; OR

16 (2) IF THE SEIZING AUTHORITY IS A UNIT OF A MUNICIPAL
17 CORPORATION, THE TREASURER OR DIRECTOR OF FINANCE OF THE MUNICIPAL
18 CORPORATION.

19 (K) (1) “OWNER” MEANS A PERSON HAVING A LEGAL, EQUITABLE, OR
20 POSSESSORY INTEREST IN PROPERTY.

21 (2) “OWNER” INCLUDES:

22 (I) A CO-OWNER;

23 (II) A LIFE TENANT;

24 (III) A REMAINDERMAN TO A LIFE TENANCY IN REAL
25 PROPERTY;

26 (IV) A HOLDER OF AN INCHOATE INTEREST IN REAL
27 PROPERTY; AND

28 (V) A BONA FIDE PURCHASER FOR VALUE.

(L) (1) "PROPERTY" INCLUDES:

(I) REAL PROPERTY AND ANYTHING GROWING ON OR ATTACHED TO REAL PROPERTY;

(II) TANGIBLE AND INTANGIBLE PERSONAL PROPERTY, INCLUDING:

- 1. SECURITIES;**
- 2. NEGOTIABLE AND NONNEGOTIABLE INSTRUMENTS;**
- 3. VEHICLES AND CONVEYANCES OF ANY TYPE;**
- 4. PRIVILEGES;**
- 5. INTERESTS;**
- 6. CLAIMS; AND**
- 7. RIGHTS;**

(III) AN ITEM, OBJECT, TOOL, SUBSTANCE, DEVICE, OR WEAPON USED IN CONNECTION WITH A VIOLATION OF THE HUMAN TRAFFICKING LAW; AND

(IV) MONEY.

(2) "PROPERTY" DOES NOT INCLUDE:

(I) AN ITEM UNLAWFULLY IN THE POSSESSION OF A PERSON OTHER THAN THE OWNER WHEN USED IN CONNECTION WITH A VIOLATION OF THE HUMAN TRAFFICKING LAW; OR

(II) A LESSOR'S INTEREST IN PROPERTY SUBJECT TO A BONA FIDE LEASE, UNLESS THE FORFEITING AUTHORITY CAN SHOW THAT THE LESSOR PARTICIPATED IN A VIOLATION OF THE HUMAN TRAFFICKING LAW OR THAT THE PROPERTY WAS THE PROCEEDS OF A VIOLATION OF THE HUMAN TRAFFICKING LAW.

(M) (1) "REAL PROPERTY" MEANS LAND OR AN IMPROVEMENT TO LAND.

(2) "REAL PROPERTY" INCLUDES:

1 (I) A LEASEHOLD OR OTHER LIMITED INTEREST IN
2 PROPERTY;

3 (II) AN EASEMENT; AND

4 (III) A REVERSIONARY INTEREST IN A 99-YEAR GROUND
5 LEASE RENEWABLE FOREVER.

6 (N) “SEIZING AUTHORITY” MEANS A LAW ENFORCEMENT UNIT IN THE
7 STATE THAT IS AUTHORIZED TO INVESTIGATE VIOLATIONS OF THE HUMAN
8 TRAFFICKING LAW AND THAT HAS SEIZED PROPERTY UNDER THIS SUBTITLE.

11 (1) EXCEPT AS PROVIDED IN § 13-503 OF THIS SUBTITLE,
12 CONVEYANCES, INCLUDING AIRCRAFT, VEHICLES, OR VESSELS USED OR
13 INTENDED TO BE USED IN CONNECTION WITH A VIOLATION OF THE HUMAN
14 TRAFFICKING LAW;

15 (2) BOOKS, RECORDS, TELECOMMUNICATION EQUIPMENT, OR
16 COMPUTERS USED OR INTENDED TO BE USED IN CONNECTION WITH A
17 VIOLATION OF THE HUMAN TRAFFICKING LAW;

18 (3) MONEY OR WEAPONS USED OR INTENDED TO BE USED IN
19 CONNECTION WITH A VIOLATION OF THE HUMAN TRAFFICKING LAW;

20 (4) EXCEPT AS PROVIDED IN § 13-503 OF THIS SUBTITLE, REAL
21 PROPERTY USED OR INTENDED TO BE USED IN CONNECTION WITH A VIOLATION
22 OF THE HUMAN TRAFFICKING LAW; AND

23 (5) EXCEPT AS PROVIDED IN § 13-503 OF THIS SUBTITLE,
24 EVERYTHING OF VALUE FURNISHED, OR INTENDED TO BE FURNISHED, IN
25 EXCHANGE FOR AN ACT IN VIOLATION OF THE HUMAN TRAFFICKING LAW, ALL
26 PROCEEDS TRACEABLE TO THE EXCHANGE, AND ALL NEGOTIABLE
27 INSTRUMENTS AND SECURITIES USED, OR INTENDED TO BE USED, TO
28 FACILITATE A VIOLATION OF THE HUMAN TRAFFICKING LAW.

30 (A) PROPERTY OR AN INTEREST IN PROPERTY DESCRIBED IN §
31 13-502(A)(1), (4), OR (5) OF THIS SUBTITLE MAY NOT BE FORFEITED IF THE
32 OWNER ESTABLISHES BY A PREPONDERANCE OF THE EVIDENCE THAT THE

1 VIOLATION OF THE HUMAN TRAFFICKING LAW WAS COMMITTED WITHOUT THE
2 OWNER'S ACTUAL KNOWLEDGE.

3 (B) (1) A CONVEYANCE USED AS A COMMON CARRIER OR VEHICLE
4 FOR HIRE IN THE TRANSACTION OF BUSINESS AS A COMMON CARRIER OR
5 VEHICLE FOR HIRE MAY NOT BE SEIZED OR FORFEITED UNDER THIS SUBTITLE
6 UNLESS IT APPEARS THAT THE OWNER OR OTHER PERSON IN CHARGE OF THE
7 CONVEYANCE WAS A CONSENTING PARTY OR PRIVY TO A VIOLATION OF THE
8 HUMAN TRAFFICKING LAW.

9 (2) A CONVEYANCE MAY NOT BE FORFEITED UNDER THIS
10 SUBTITLE FOR AN ACT OR OMISSION THAT THE OWNER SHOWS WAS COMMITTED
11 OR OMITTED BY A PERSON OTHER THAN THE OWNER WHILE THE PERSON OTHER
12 THAN THE OWNER POSSESSED THE CONVEYANCE IN CRIMINAL VIOLATION OF
13 FEDERAL LAW OR THE LAW OF ANY STATE.

14 (C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS
15 SUBSECTION, REAL PROPERTY USED AS THE PRINCIPAL FAMILY RESIDENCE
16 MAY NOT BE FORFEITED UNDER THIS SUBTITLE UNLESS ONE OF THE OWNERS
17 OF THE REAL PROPERTY WAS CONVICTED OF A VIOLATION OF THE HUMAN
18 TRAFFICKING LAW OR OF AN ATTEMPT OR CONSPIRACY TO VIOLATE THE HUMAN
19 TRAFFICKING LAW.

20 (2) WITHOUT A CONVICTION, A COURT MAY ORDER A
21 FORFEITURE OF REAL PROPERTY USED AS THE PRINCIPAL FAMILY RESIDENCE
22 IF THE OWNER OF THE FAMILY RESIDENCE:

23 (I) FAILS TO APPEAR FOR A REQUIRED COURT
24 APPEARANCE; AND

25 (II) FAILS TO SURRENDER TO THE JURISDICTION OF THE
26 COURT WITHIN 180 DAYS AFTER THE REQUIRED COURT APPEARANCE.

27 (D) REAL PROPERTY USED AS THE PRINCIPAL FAMILY RESIDENCE BY A
28 HUSBAND AND WIFE AND HELD BY THE HUSBAND AND WIFE AS TENANTS BY THE
29 ENTIRETY MAY NOT BE FORFEITED UNLESS:

30 (1) THE PROPERTY WAS USED IN CONNECTION WITH A VIOLATION
31 OF THE HUMAN TRAFFICKING LAW OR WITH AN ATTEMPT OR CONSPIRACY TO
32 VIOLATE THE HUMAN TRAFFICKING LAW; AND

33 (2) BOTH THE HUSBAND AND WIFE ARE CONVICTED OF A
34 VIOLATION OF THE HUMAN TRAFFICKING LAW OR OF AN ATTEMPT OR
35 CONSPIRACY TO VIOLATE THE HUMAN TRAFFICKING LAW.

3 **SEIZED:**

4 **(1) ON A WARRANT ISSUED BY A COURT THAT HAS JURISDICTION**
5 **OVER THE PROPERTY; AND**

6 **(2) WITHOUT A WARRANT WHEN:**

7 **(I) THE SEIZURE IS INCIDENT TO AN ARREST OR A SEARCH**
8 **UNDER A SEARCH WARRANT;**

9 **(II) THE SEIZURE IS INCIDENT TO AN INSPECTION UNDER**
10 **AN ADMINISTRATIVE INSPECTION WARRANT;**

11 **(III) THE PROPERTY SUBJECT TO SEIZURE HAS BEEN THE**
12 **SUBJECT OF A PRIOR JUDGMENT IN FAVOR OF THE STATE IN A CRIMINAL**
13 **INJUNCTION OR FORFEITURE PROCEEDING UNDER THIS SUBTITLE;**

14 **(IV) THERE IS PROBABLE CAUSE TO BELIEVE THAT THE**
15 **PROPERTY IS DIRECTLY OR INDIRECTLY DANGEROUS TO HEALTH OR SAFETY;**
16 **OR**

17 **(V) THERE IS PROBABLE CAUSE TO BELIEVE THAT THE**
18 **PROPERTY HAS BEEN USED OR IS INTENDED TO BE USED IN VIOLATION OF THE**
19 **HUMAN TRAFFICKING LAW OR THIS SUBTITLE.**

21 **(A) THE SEIZING AUTHORITY THAT SEIZES MONEY UNDER THIS**
22 **SUBTITLE SHALL IMMEDIATELY:**

23 **(1) PHOTOGRAPH THE MONEY AND RECORD THE QUANTITY OF**
24 **EACH DENOMINATION OF COIN OR CURRENCY SEIZED; AND**

25 **(2) DEPOSIT THE MONEY TO THE ACCOUNT OF THE APPROPRIATE**
26 **LOCAL FINANCIAL AUTHORITY.**

27 **(B) A PHOTOGRAPH TAKEN UNDER SUBSECTION (A) OF THIS SECTION**
28 **MAY BE SUBSTITUTED FOR MONEY AS EVIDENCE IN A CRIMINAL OR FORFEITURE**
29 **PROCEEDING.**
