CHAPTER _____

1 AN ACT concerning

2 **Workers' Compensation – Jurisdiction Pending Appeal – Proposed**
3 **Settlement**

4 FOR the purpose of expanding the circumstances under which the Workers'
5 Compensation Commission retains jurisdiction pending an appeal of a
6 Commission order to include a request for approval of a proposed settlement of
7 all or part of a claim; and generally relating to the jurisdiction of the
8 Commission pending an appeal of a workers' compensation order.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Labor and Employment**

17 9–742.

18 (a) The Commission retains jurisdiction pending an appeal to consider:

1 (1) a request for additional medical treatment and attention; [and]

2 (2) a request for temporary total disability benefits, provided that the
3 covered employee's temporary total disability benefits were granted in the order on
4 appeal, and were terminated by the insurer or self-insurer pending adjudication or
5 resolution of the appeal; AND

6 **(3) A REQUEST FOR APPROVAL OF A PROPOSED SETTLEMENT OF**
7 **ALL OR PART OF A CLAIM.**

8 (b) (1) If the Commission finds that a covered employee needs additional
9 medical attention pending an appeal, the Commission may pass a supplemental order
10 requiring the employer to provide additional medical treatment and attention.

11 (2) If the Commission finds that a covered employee's temporary total
12 disability benefits were terminated pending adjudication or resolution of the appeal,
13 and that the employee was temporarily totally disabled at the time of termination, the
14 Commission may pass a supplemental order requiring the employer to provide the
15 employee with temporary total disability benefits.

16 (3) If the Commission's decision to reinstate temporary total disability
17 benefits is reversed or modified on appeal, the insurer or self-insurer shall be entitled
18 to an offset or credit for overpayment of the temporary total disability benefits granted
19 in the supplemental order.

20 (c) A supplemental order passed by the Commission under this section is
21 subject to review on the pending appeal.

22 (d) When an appeal that is pending relates solely to a penalty imposed by the
23 Commission, the Commission retains jurisdiction over all matters in the case other
24 than imposition of the penalty.

25 (e) This section may not be construed to prevent the Commission from
26 ordering an offset or credit against an award for temporary total or permanent partial
27 disability benefits for any temporary total disability benefits previously paid to a
28 covered employee, as authorized under any other provision of this title.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2011.
