BY repealing Article – Family Law Section 5–552.1 Annotated Code of Maryland (2006 Replacement Volume and 2010 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Family Law [5-552.1. There is an amnesty period, to be determined by the Department, (a) (1) for unregistered family day care providers.

The purpose of the amnesty period is to encourage compliance with

- 1 (b) The amnesty is intended to encourage compliance with registration 2 requirements by:
- 3 (1) having unregistered family day care providers voluntarily enter 4 the registration process; and
- 5 (2) allowing unregistered family day care providers participating in 6 the amnesty program to continue providing child care during the registration process.
- 7 (c) (1) (i) Notwithstanding any other provision of this Part V, from 8 October 1, 1994 to September 30, 1997, there shall be an amnesty period in each of those years for unregistered family day care providers as provided in subparagraph (ii) of this paragraph to allow unregistered family day care providers to continue in operation while becoming registered in accordance with the provisions of this section.
- 12 (ii) Except as provided in subparagraph (iii) of this paragraph, 13 the amnesty period shall be 12 months for each year from October 1, 1994 to 14 September 30, 1997.
- 15 (iii) Subject to subparagraph (iv) of this paragraph, the 16 Department may reduce the number of months in the amnesty period to not less than 17 2 months for each of the 2 years from October 1, 1995 to September 30, 1997, if the 18 Department finds that a 12-month period is not feasible.
- 19 (iv) If the Department reduces the number of the months in the 20 amnesty period under subparagraph (iii) of this paragraph, the Department shall 21 notify the General Assembly in writing, in accordance with § 2–1246 of the State 22 Government Article.
- 23 (2) The State Superintendent shall adopt regulations for the 24 implementation of the amnesty program.
- 25 (d) (1) The amnesty shall apply only to the registration required by this 26 Part V, but only if the requirements of subsection (e) of this section are met.
- 27 (2) Any unregistered family day care provider participating in the 28 amnesty:
- 29 (i) may not be enjoined by the Department as long as 30 information is not made known to the Department that the health, safety, or welfare 31 of any child in the care of the unregistered family day care provider is endangered, 32 including any information or evidence provided by a State or local code enforcement 33 authority or protective services or law enforcement agency;
- 34 (ii) is not subject to the penalty provided for in § 5–557 of this
- 35 Part V; and

3 4	(e) For the purposes of this section, an unregistered family day care provider is participating in the amnesty program if:
5	(1) the unregistered family day care provider:
6 7 8	(i) between October 1, 1994 and September 30, 1997, files an application with the Department in accordance with the regulations adopted by the Department; and
9 10 11	(ii) makes a good faith effort, as determined by the Department, to complete the registration process within 1 year of the date of entering the amnesty; and

17 18 19 20 21 22 23 24	(f) Notwithstanding any other provision of law, except for any willful or grossly negligent act, a State or local code enforcement authority, protective services or law enforcement agency, the Department of Human Resources, State Department of Education, and the personnel of a State or local code enforcement authority, protective services or law enforcement agency, the Maryland Department of Human Resources, or the State Department of Education shall be immune from civil liability for any act or injury to any child attributable to or resulting from the amnesty period provided for in this section.]
