Vehicle Laws - Provisional Driver's Licenses - Driver Education Requirements

- 4 FOR the purpose of reducing the period of time that certain individuals at least a 5 certain age who hold a learner's instructional permit are required to wait before 6 taking certain examinations for a provisional driver's license; establishing that 7 certain driving practice requirements and a requirement to complete a certain 8 driver skills log book before taking certain examinations for a provisional 9 driver's license do not apply to an individual at least a certain age: authorizing 10 individuals at least a certain age to complete certain driver education 11 requirements through a certain Internet program; requiring the Motor Vehicle Administration to adopt regulations establishing curriculum, equipment, and 12 standards for a certain Internet driver education program; and generally 13 relating to driver education requirements for obtaining a provisional driver's 14 15 license.

- 24 UNTIL (II)AFTER SUCCESSFUL **COMPLETION** OF A STANDARD OR AN INTERNET DRIVER EDUCATION PROGRAM APPROVED UNDER 25 26 SUBTITLE 5 OF THIS TITLE, CONSISTING OF AT LEAST 30 HOURS OF CLASSROOM 27 OR INTERNET INSTRUCTION AND AT LEAST 6 HOURS OF HIGHWAY DRIVING 28 INSTRUCTION.
