13 14 15 16	(3) If the child was adopted under the laws of a jurisdiction or country other than the United States and has been granted an IR-3 OR IH-3 visa by the United States Immigration and Naturalization Service under the Immigration and Nationality Act, the certificate shall be established [upon] ON receipt of:
17 18	(i) An official copy of the decree from the jurisdiction or country in which the child was adopted;
19	(ii) A certified translation of the foreign adoption decree;
20	(iii) Proof of the date and place of the child's birth;
21	(iv) Proof of IR-3 OR IH-3 visa status;
22 23	(v) A request from the court, the adopting parents, or the adopted person if 18 years of age or over that the certificate be prepared; and
