## 2 Baltimore City – Alcoholic Beverages – Class B–D–7 License Holders – 3 Security Plan

FOR the purpose of requiring in Baltimore City certain holders and applicants of a Class B-D-7 alcoholic beverages license to comply with certain requirements regarding a certain security plan for their premises; requiring applicants and holders of a Class B-D-7 license who offer certain entertainment to develop a security plan and submit the plan for review to certain individuals the Board of Liquor License Commissioners for Baltimore City: authorizing the Commissioner of the Baltimore City Police Department to submit certain comments to the Board of Liquor License Commissioners for Baltimore City; requiring authorizing the Board to take certain actions under certain <del>circumstances</del> regarding the issuance or renewal of a license; requiring certain license holders to implement and follow certain security plans and prohibit underage individuals on the premises; providing for a certain exception; authorizing certain license holders to employ sworn security personnel under eertain eircumstances; authorizing the Board immediately to suspend certain licenses under certain circumstances; requiring the Board to take certain actions if it immediately suspends a license; authorizing the Board to revoke or continue a suspension of a license under certain circumstances; requiring the Board to impose certain penalties under certain circumstances; requiring the Board to consider certain factors when setting the amount of certain penalties; requiring the Board to revoke certain licenses under certain circumstances; prohibiting the Board from considering, at least for a certain period of time, an application for a new license from the person whose license was revoked or an
