14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 18 (a) The County Commissioners by ordinance may designate that part of
 19 Smith Island in Somerset County as a solid waste district for the sole purpose of
 20 imposing an annual fee on improved property on Smith Island to offset the cost of
 21 removing solid waste, including ash and other residue from the County's incinerator,
 22 from Smith Island.
- 23 (b) [(1)] A fee imposed by ordinance under this section shall be compatible 24 to the costs incurred by other property owners in Somerset County for disposal of solid 25 waste.

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
