1 (b) The Fund is a nonlapsing revolving fund which is not subject to § 7–302 2 of the State Finance and Procurement Article.

(c) The Fund shall be used to pay:

4 (1) [The operating expenses of the land records offices of the clerks of 5 the circuit courts and to repair, replace, improve, modernize, and update] FOR THE 6 REPAIR, REPLACEMENT, IMPROVEMENT, MODERNIZATION, AND UPDATING OF 7 office equipment and equipment related services in the land records office of the clerk 8 of the circuit court for each county, as the Administrator considers appropriate, with 9 advice from the oversight committee; and

10 (2) For [fiscal years 2009 and 2010, for] major information technology 11 development projects of the Judiciary Department, as the Administrator considers 12 appropriate.

(d) Expenditures under this section shall only be made pursuant to an
 appropriation approved by the General Assembly in the annual State budget prior to
 the expenditure or obligation of funds.

16 (e) The Fund shall be subject to an audit by the Office of Legislative Audits 17 as provided for in § 2–1220 of the State Government Article.

18 (f) Disbursements from the Fund shall supplement and may not be a 19 substitute for any funds designated in the State budget for office equipment and 20 services in the land records office of the clerk of the circuit court for each county.

SECTION 2. AND BE IT FURTHER ENACTED, That, as of July 1, 2011, and for each fiscal year thereafter, the operating expenses for the salaries and benefits of the employees of the land records office of the clerk of the circuit court for each county and Baltimore City shall be paid from the General Fund of the State.
