- FOR the purpose of authorizing the Board of Liquor License Commissioners for Baltimore City to issue a Class C beer, wine and liquor license in the 45th alcoholic beverages district; <u>authorizing the holder of a Class A license to</u> <u>exercise off-sale privileges on a certain number of additional Sundays during a</u> <u>calendar year; requiring that a certain license fee be paid before a certain time;</u> <u>increasing the number of Sundays during which certain Class D licensees may</u> <u>sell alcoholic beverages during a calendar year; making a certain stylistic</u>
- 10 <u>change</u>; and generally relating to alcoholic beverages in Baltimore City.

4 <u>(a) (3) (i) Except for the Class B Sunday off-sale license prohibition in</u> 5 <u>the 47th alcoholic beverages district in Baltimore City as provided for in § 6–201(d) of</u> 6 <u>this article, in Baltimore City a Class B and a Class C beer and light wine or beer,</u> 7 <u>wine and liquor licensee may sell alcoholic beverages at a bar or counter on Sunday.</u>

8 Subject to the conditions provided (ii) 1. in 9 SUBSUBPARAGRAPH 2 OF this subparagraph AND IN ADDITION TO 10 SUBPARAGRAPH (III) OF THIS PARAGRAPH, in Baltimore City, a holder of a Class A retail alcoholic beverages license may exercise the off-sale license privilege on the 11 Sundays that fall between Thanksgiving Day and New Year's Day from 1 p.m. to 9 1213<u>p.m.</u>

14 <u>2.</u> The holder of a Class A retail off-sale license may
15 exercise the additional privilege authorized by this subparagraph in any year in which
16 a supplementary license fee of \$75 has been paid prior to October 1 for each day the
17 additional privilege is to be exercised.

18(III)1.THE HOLDER OF A CLASS A RETAIL ALCOHOLIC19BEVERAGES LICENSE IN BALTIMORE CITY MAY EXERCISE THE OFF-SALE20PRIVILEGE ON TWO ADDITIONAL SUNDAYS DURING THE CALENDAR YEAR.

21 <u>2. A HOLDER SHALL PAY A LICENSE FEE OF \$75 AT</u> 22 <u>LEAST 2 WEEKS BEFORE EACH TIME THE PRIVILEGE IS EXERCISED UNDER THIS</u> 23 SUBPARAGRAPH.

25 (a) In Baltimore City an amusement license shall authorize the holder
26 thereof to keep for sale and sell all alcoholic beverages at all hours except between the
27 hours of 2 o'clock a.m. and 6 o'clock a.m. of each day.

28 (b) (2) (i) The Board may issue a supplemental license no more than 29 [two] FOUR times during any calendar year to a holder of a Class D beer, wine and 30 liquor license authorizing the holder to sell alcoholic beverages between the hours of 6 31 a.m. on Sunday and 1 a.m. the following day.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 33 July 1, 2011.
