11	during a certain period by including payments to certain slates; repealing a
12 13	provision that allows a member to participate in certain applications if a certain affidavit is not filed; providing for the prospective application of this Act; and
14	generally relating to the expansion of public ethics requirements in Prince

- 28 (a) An applicant or agent of the applicant may not make a payment to a
