## Real Property – Condominiums and Homeowners Associations – Governing Bodies

FOR the purpose of requiring the governing body of a condominium to convene at least a certain number of meetings each year; requiring the developer of a condominium to appoint a certain person to the governing body within a certain period of time from the date a certain number of units are conveyed under certain circumstances; requiring a developer to deliver certain notices regarding a certain bond to certain individuals within a certain period of time; requiring a council of unit owners to keep books, records, and accounts, beginning on the date the council is established; requiring a council of unit owners to maintain certain books, records, and accounts in a certain manner; making certain provisions of law applicable to the accounts of a condominium; requiring a declarant to appoint a certain person to the governing body of a homeowners association within a certain period of time from the date a certain number of lots are sold under certain circumstances; requiring a declarant to deliver certain notices regarding a certain bond to certain individuals within a certain period of time; requiring the governing body of a homeowners association to convene at least a certain number of meetings each year; requiring a homeowners association to maintain books, records, and accounts, beginning on the date the homeowners association is established; requiring a homeowners association to maintain certain books, records, and accounts in a certain manner; making certain provisions of law applicable to the accounts of a homeowners association; and generally relating to the governing bodies of condominium councils of unit owners and homeowners associations.
