10. Description and Purpose of Grantee Organization (Limit Length to Visible area)				
<p>Arundel Lodge, Inc. works in full partnership to inspire and respectfully assist each person's recovery from mental illness by integrating supports, skills, and encouragement, so that each individual achieves a satisfying and meaningful life in the community. ALI provides evidence-based and recovery-focused mental health services, promotes the use of natural supports, and partners with community-based organizations and social service agencies. Arundel Lodge services include an Outpatient Mental Health Clinic, Day Program, Offsite Community Rehabilitation, Supported Employment, and Residential Rehabilitation.</p>				

11. Description and Purpose of Project (Limit Length to Visible area)

The purpose of this project is to convert the unfinished basement at Arundel Lodge's headquarters into program space and redesign space on the second floor for an expanded OMHC. The basement will be utilized for two rehabilitation classrooms, two program offices, and a conference room. The space vacated by the two program offices moving to the basement will be redesigned to accommodate an expanded OMHC. Arundel Lodge opened its outpatient clinic in May of 2008 with approximately 225 patients largely because access to mental health services was a major problem in Anne Arundel County. The OMHC is currently serving 650 persons. To meet the growing needs, Arundel Lodge is building its capacity to provide outpatient services, adding professional staff, providing state-of-the-art training, and expanding clinic and classroom space.
