**FISCAL AND POLICY NOTE**

Senate Bill 472

(Carroll County Senators)

Education, Health, and Environmental Affairs

**Carroll County - Commissioners - Term Limits and Vacancies**

---

This bill establishes that the term of office for county commissioners in Carroll County is four years and that commissioners may not serve more than two consecutive terms. The bill also specifies that a person appointed to fill a vacancy must reside in that commissioner district and serve only the remainder of the term.

---

**Fiscal Summary**

**State Effect:** None.

**Local Effect:** None. The bill will not materially alter Carroll County operations or finances.

**Small Business Effect:** None.

---

**Analysis**

**Current Law:** The Carroll County Board of County Commissioners is comprised of five commissioners that are elected by commissioner district. Each county commissioner is entitled to an annual salary of \$45,000 and an allowance for expenses incurred in the performance of the duties of that office, as provided in the county budget.

To be eligible to serve as a county commissioner, an individual must be at least 21 years of age, a State resident, and have been a resident in Carroll County for at least one year preceding the date of the election.

The five commissioner districts consist of the following election districts and precincts as they existed on December 1, 2005:

- Commissioner District 1 – Carroll County Election Districts 1, 2, 3, 6, and 10;
- Commissioner District 2 – Carroll County Election Districts 4 and 8;
- Commissioner District 3 – Carroll County Election District 7, Precincts 1 through 7, 9, and 10;
- Commissioner District 4 – Carroll County Election District 7, Precinct 8, Carroll County Election Districts 9, 11, 12, and 13, and Carroll County Election District 14, Precincts 2 and 3; and
- Commissioner District 5 – Carroll County Election District 5 and Carroll County Election District 14, Precinct 1.

**Background:** There are three forms of county government in Maryland: commission, charter home rule, and code home rule. **Exhibit 1** shows the form of government for each Maryland county and the year in which local home rule was granted.

In all counties except Cecil County (since 2000), county commissioners are elected for four-year terms, coincident with the election of the Governor and members of the General Assembly. In Cecil County, the commissioners are elected to four-year terms; however, two commissioners are elected in presidential election years and three commissioners are elected in gubernatorial election years.
