Somerset County - Deputy State's Attorney - Private Practice

This emergency bill repeals a prohibition against the deputy State's Attorney for Somerset County engaging in the private practice of law.

Fiscal Summary

State Effect: None.

Local Effect: None. The bill does not materially affect Somerset County finances.

Small Business Effect: None.

Analysis

Current Law: The State's Attorney and deputy State's Attorney for Somerset County are prohibited from engaging in the private practice of law.

Background: In general, eight counties statutorily prohibit their deputy State's Attorneys from engaging in the private practice of law. **Exhibit 1** contains the statutory prohibitions in the Maryland Code on the private practice of law for State's Attorneys, deputy State's Attorneys, and assistant State's Attorneys.
