<p>The Corporation is formed and organized pursuant to the provisions of the Act as a non-stock corporation to enhance economic activity, the quality of life and vitality of cities, towns, communities and neighborhoods along and abutting or in proximity to U.S. Route 301 in the State of Maryland (the "Project Area") through encouraging public and private investment and development, including, without limitation, capital improvement projects, in the Project Area by: (1) raising funds from any lawful source for the purpose of engaging in capital reinvestment and other charitable activities; (2) serving as a model for the comprehensive redevelopment and renewal of physical and human resources within the Project Area through the combined efforts of public, private, foundation, educational and institutional participants; (3) engaging in activities designed to educate the general public on public policies, human service reforms, and community initiatives that more effectively meets the need for combating community deterioration.</p>
