10. Description and Purpose of Grantee Organization (Limit Length to Visible area)									

The American Visionary Art Museum (AVAM) is the country's official museum and education center for self-taught artistry by unanimous vote of US Congress. AVAM utilizes art to explore and expand the definition of individual human potential, dignity, and community. AVAM studies, collects, preserves, and exhibits visionary art and seeks to increase the public's awareness, knowledge, and understanding of visionary art. At the very heart of AVAM's mission is a belief in the power of creativity. Nothing promotes human IMAGINATION like the arts - the fuel for all creative invention be it then applied to science, engineering, enterprise, literature, or compassionate social betterment. Nearly 10,000 children participate in AVAM's education programs, which link art to the broader context of creative achievement in science, medicine, music, literature, invention, and industry. It is the only museum of its kind in the world, a unique treasure for Maryland, which draws in a national and international audience of almost 100,000 annually.

11. Description and Purpose of Project (Limit Length to Visible area)

AVAM is located in a prime cultural, historical, and tourist hub. Nestled beside historic Federal Hill and overlooking the Inner Harbor, the museum's 1.1-acre campus is a lynch-pin for the downtown cultural area while linking it with extended areas of cultural interest, such as Locust Point and Federal Hill. Currently, AVAM is operating with an over 15-year old security system that is in need of updating. The analog cameras used in our system produce only grainy images, and their limited number produces "blind spots" in the security footage. Thus, we are seeking Maryland State support for capital equipping and planning to address our campus-wide security needs. AVAM's first step will be to complete a thorough security assessment, pinpointing specific areas of need and improvement. The second phase of the project addresses the out-dated security system by replacing the old analog cameras with updated digital equipment, and increase their number. These improvements will not only allow the museum to protect its treasures and provide visitors with peace-of-mind but also serve the local community. AVAM will be able to monitor the immediate area surrounding Federal Hill, helping to deter crime and the systemic car break-ins that plague the neighborhood.

Thank you for your past support and understanding of the importance of education and creative vision for all of Maryland's citizens. Our American Visionary Art Museum utilizes art to explore nad expand the definition of individual human potential, dignity, and community. Nothing promotes human IMAGINATION like the arts - the fuel for all creative invention be it then applied to science, engineering, enterprise, literature, or compassionate social betterment. Your steadfast commitment to the stability and growth of Maryland's lively and respected cultural and educational institutions is vital to our state's cultural and tourism economy as well as the success of our next generation!

We are, of course, very respectful of the hard economic climate this year and understanding of tough decisions you must make this session. AVAM does not make a regular habit of requesting bonds from the state, but we find ourselves in urgent need of security improvements to our facilities. Therefore, we urge support from the Maryland State Legislature for our request of \$55,000 Bond Bill toward our capital equipping and planning for a state-of-the-art campus-wide security system (endorsed and cross-filed by Delegate Brian K. McHale and Senator William Ferguson). We have a full matching funds in-hand to meet the State's monies. AVAM's security system is 15 years old, dating back to the museum's opening, and in dire need of upgrading. As such, our project includes two levels. First, we will conduct a campus-wide security assessment, identifying problem areas and necessary repairs and upgrades. Second, AVAM will replace its old analog cameras with new digital versions and increase their number.

In 1993, AVAM broke ground to renovate the Baltimore Copper Paint Company building. AVAM opened in 1995, with a modern swirling addition that complements the shape of the original brick structure, and contains approximately 9,000 sq. ft. of climatized exhibition space, museum shop, visitor welcome area, storage, library, and offices, all 100% handicap accessible. Shortly after opening, the building received an Urban Land Institute award for architectural design. Then, in 2005, AVAM doubled the size of its campus, renovating the old Rose Whiskey warehouse providing new exhibition and classroom space while maintaining the historic elements of the building. Ultimately, the story of AVAM's responsible, adaptive re-use mirrors the trajectory of Baltimore itself. As the museum makes history and plays a national cultural role, the original buildings are guaranteed a continued role in creating a strong Baltimore. It is imperative that AVAM provides exceptional security for the campus, its holdings, and annual visitors.

Maryland State funds have been critical to AVAM, the congressionally-designated museum and education center for self-taught and intuitive artistry. Thank you for your consideration of our request for equipping and planning that can not be put off any longer.
