<p>Crossland High School is a comprehensive, public secondary school of nearly 1,500 students. Crossland expects students to excel at a high level of academic achievement and go to college or attain other post-secondary education.</p> <p>Crossland offers a rigorous, traditional comprehensive high school program that includes a selection of Advanced Placement classes and a Technical Academy magnet. The academy is designed to provide students with marketable skills in cosmetology, drafting, nursing, masonry, air conditioning/refrigeration, printing, and culinary arts. The school also offers an International Baccalaureate (IB) Program for students who desire additional academic stimulation and intellectual challenges.</p>

The purpose of this project is to purchase a press box for the Crossland High School football stadium. There is currently no press box at all, which means that we do not have a facility for coaches to view or film or games, nor do we have a facility for a public address announcer during our football and soccer games, nor do we have a facility for our students to learn how to announce and/or broadcast our games.

The vast majority of high schools that field interscholastic sports have this basic facility, and we believe that equity demands that our students and staff have this basic necessity as well.
