10. Description and Purpose of Grantee Organization (Limit Length to Visible area)				
<p>Meals on Wheels of Central Maryland's charitable mission is to enhance quality of life for people who are homebound through the provision of nutritious meals, personal contact and related services. Each weekday, 3,000 hot and cold meals are prepared in our Central Kitchen Facility and delivered by volunteers to approximately 1,500 clients in Baltimore City, and Anne Arundel, Carroll, Harford, and Howard counties, in addition to limited areas of Frederick and Montgomery counties. Last fiscal year, over 2,000 volunteers for our Home-Delivered Meals Program delivered 743,034 meals to 2,964 clients within our service area. The primary goal of our recently completed Strategic Plan is to double the number of clients we now serve daily by 2020. "Green Building" equipment/structural improvements will, according to professional estimates, achieve significant energy savings over current operations, over a 5-year period. These savings will enable our program to direct more financial resources toward serving growing numbers of elderly, functionally disabled, and low-income clients predicted between now and 2020.</p>				

11. Description and Purpose of Project (Limit Length to Visible area)

All elements of the Green Building Project are intended to reduce energy consumption and, thus, operating and capital expenses to a significant degree, enabling Meals on Wheels to better direct these financial resources toward increased meal production and delivery to homebound clients. The two most critical purposes of the Green Building Project are (1) replacement of a 20-year+ roof (2-Ply APP modified roof system with white granular cap sheet, three inches of ISO insulation to be installed with R value of 18), and (2) replacement of two RTUs for maximum energy efficiency, including economizers and CO-2 demand controls. Other elements of the Green Building Project include:

1. Replacement of fans in kitchen refrigeration boxes;
2. Replacement of kitchen Hot Water Tank with Tankless System (Dishwasher);
3. New Window Treatments (Insulated Blinds & Glazing);
4. Replacement of current lighting with Fluorescent Fixtures (retrofit all 2x4 fixtures, relamp & reballast 2 bulb T-8); light controllers with sensors/additional sensors; controllable plug loads strips
