Private Property Rights - Regulatory Infringement - Compensation

- 3 FOR the purpose of giving an owner of private property a cause of action under certain 4 circumstances against the Department of the Environment, the Department of 5 Natural Resources, or the Department of Planning if the application of a 6 regulation adopted by the agency infringes on a private property right; 7 providing that the cause of action shall be filed in a certain court; providing for 8 the sum that a private property owner may recover under a certain cause of 9 action; requiring the award or judgment under a certain cause of action to be 10 paid from certain funds and prohibiting payment from the General Fund; providing for the venue of a certain cause of action; establishing a certain 11 12 statute of limitations; providing for the application of this Act; defining a certain 13 term; and generally relating to the rights of private property owners.

- 1 (2) AN AWARD OR JUDGMENT IN FAVOR OF A PROPERTY OWNER 2 MADE UNDER THIS SUBTITLE MAY NOT BE PAID FROM THE GENERAL FUND OF 3 THE STATE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2012.
