A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Board of Education Residence Districts –**
3 **Redistricting Plan**

4 FOR the purpose of altering the boundaries of the residence districts for the
5 Montgomery County Board of Education; repealing a provision of law relating to
6 the date when certain reapportioned districts become effective; making this Act
7 an emergency measure; and generally relating to the residence districts for the
8 Montgomery County Board of Education.

9 BY repealing and reenacting, with amendments,
10 Article – Education
11 Section 3–901
12 Annotated Code of Maryland
13 (2008 Replacement Volume and 2011 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Education**

17 3–901.

18 (a) (1) In this subtitle the following words have the meanings indicated.

19 (2) “Elected member” means 1 of the 7 elected and voting members of
20 the Montgomery County Board or a member appointed to fill a vacancy of 1 of these 7
21 members.

22 (3) “Board of Education District” means a geographic area of
23 Montgomery County in which an elected member of the Montgomery County Board of
24 Education must be a legal resident. The geographic area of each district is described in

1 subsection (f) of this section. Each district shall be substantially equal in population,
2 and the districts shall be reapportioned on the basis of each decennial census of the
3 United States. [Reapportioned districts shall become effective for the term of office
4 commencing after the first regular primary election held at least 15 months after the
5 official report on population is received by the State from the Bureau of the Census.]

6 (b) The Montgomery County Board consists of:

7 (1) 5 elected members, each of whom resides in a different board of
8 education district;

9 (2) 2 elected members who may reside anywhere in the county; and

10 (3) 1 student member.

11 (c) An elected member of the county board shall be a registered voter of
12 Montgomery County.

13 (d) Members of the Montgomery County Board shall be elected at the general
14 election every 2 years as required by subsection (f) of this section.

15 (e) (1) The student member shall be a bona fide resident of Montgomery
16 County and a regularly enrolled junior or senior year student from a Montgomery
17 County public high school.

18 (2) The nomination and election process shall be as agreed on by the
19 county board and the Montgomery County region of the Maryland Association of
20 Student Councils. This agreement shall include a process by which to replace one or
21 both of the final candidates if they are unable to proceed in the election. Any student
22 enrolled in a middle or high school in the Montgomery County public schools may:

23 (i) Nominate a student member candidate;

24 (ii) Vote for delegates from the student's school, who in turn
25 vote in a nominating convention to reduce to 2 the number of candidates for student
26 board member if there are 3 or more candidates; and

27 (iii) Vote directly for 1 of the 2 remaining student board member
28 candidates.

29 (3) The candidate receiving the second highest number of votes in the
30 direct election shall become the alternate student member. The alternate shall serve if
31 the student member is unable to complete his elected term.

32 (4) Except as provided in paragraphs (5), (6), and (7) of this
33 subsection, the student member has the same rights and privileges of an elected
34 member.

1 (5) Unless invited to attend by the affirmative vote of a majority of the
2 county board, the student member may not attend an executive session that relates to:

3 (i) Hearings held under § 6–202(a) of this article; or

4 (ii) Collective bargaining.

5 (6) As provided in paragraph (7) of this subsection, the student
6 member shall vote on all matters except those relating to:

7 (i) § 6–202(a) of this article;

8 (ii) Collective bargaining;

9 (iii) Capital and operating budgets; and

10 (iv) School closings, reopenings, and boundaries.

11 (7) On a majority vote of the elected members, the board may
12 determine, on a case by case basis, whether a matter under consideration is covered by
13 the exclusionary provisions listed in paragraph (6) of this subsection.

14 (f) (1) Each elected member serves for a term of 4 years beginning on
15 December 1 after the member's election and until a successor is elected and qualifies.
16 The terms of elected members are staggered as required by the terms of the members
17 serving on the county board as of July 1, 1978 so that 4 members are elected in
18 gubernatorial election years and 3 members are elected in presidential election years.

19 (2) Elected members of the county board shall be elected by the voters
20 of the entire county.

21 (3) (i) Of the 3 members elected in 1992 and every 4 years
22 thereafter, 1 shall reside in Board of Education District 2 and 1 shall reside in Board
23 of Education District 4. The third member may reside in any part of the county.

24 (ii) Of the 4 members elected in 1990 and every 4 years
25 thereafter, 1 shall reside in Board of Education District 1, 1 shall reside in Board of
26 Education District 3, and 1 shall reside in Board of Education District 5. The fourth
27 member may reside in any part of the county.

28 (iii) The descriptions of board of education districts in this
29 subsection refer to the geographical boundaries of the election districts and the
30 precincts:

31 1. As reviewed and certified by the Montgomery County
32 Board of Elections or its designees, before the precinct boundaries were reported to the

1 U.S. Bureau of the Census as part of the [2000] **2010** Census Redistricting Data
2 Program; and

3 2. As those precinct lines are specifically shown on the
4 P.L. 94–171 census block maps provided by the U.S. Bureau of the Census and as
5 reviewed and corrected by the [Department of Planning] **DIVISION OF LONG–RANGE**
6 **PLANNING OF THE MONTGOMERY COUNTY PUBLIC SCHOOLS.**

7 **(IV) WHERE PRECINCTS ARE SPLIT BETWEEN BOARD OF**
8 **EDUCATION DISTRICTS, CENSUS TRACT AND BLOCK NUMBERS, AS INDICATED**
9 **IN THE P.L. 94–171 DATA OR SHOWN ON THE P.L. 171 CENSUS BLOCK MAPS**
10 **PROVIDED BY THE U.S. BUREAU OF THE CENSUS AND REFERRED TO IN THIS**
11 **SUBTITLE, ARE USED TO DEFINE THE BOUNDARIES OF THE EDUCATION**
12 **DISTRICTS.**

13 [(iv) Board of Education District 1 consists of:

14 1. Election district 1, precincts 2 and 3;

15 2. Election district 2, precincts 1, 3, and 5;

16 3. Election district 3;

17 4. Election district 9, precincts 1, 3, 5, 7, 8, 9, 11, 12, 13,
18 15 through 19, 22, 23, 24, 25, 27, 28, 29, and 30;

19 5. Election district 11;

20 6. Election district 12;

21 7. That part of election district 1, precinct 1 that is
22 generally the northern part of precinct 1 which extends from the precinct boundary
23 north along the center of Laytonsville Olney Road, then south along the center of Field
24 Crest Road to a line going south just west of Stream Valley Way to Rock Creek, then
25 south along Rock Creek to its intersection with Field Crest Road, then west along the
26 center of Field Crest Road to the precinct boundary;

27 8. That part of election district 1, precinct 4 that is
28 generally the northern part of precinct 4 which extends from the precinct boundary,
29 then goes west on a line just north of Hadley Farms Road and includes all streets off of
30 Hadley Farms Drive to Chain Branch Tributary (a creek), then south along Chain
31 Branch Tributary to the precinct boundary;

32 9. That part of election district 2, precinct 2 that is
33 generally the northern part of precinct 2 which extends from the precinct boundary

1 north along a line just east of Clarksburg Road to the shore of Lake Seneca and the
2 precinct boundary;

3 10. That part of election district 6, precinct 3 that is
4 generally the northern and southern parts of precinct 3 which extends from the
5 precinct boundary west along the center of Great Seneca Highway to the precinct
6 boundary, then along the precinct boundary to its intersection with Great Seneca
7 Creek, then east-southeast along the Great Seneca Creek to the precinct boundary;

8 11. That part of election district 9, precinct 2 that is
9 generally the northern part of precinct 2 which extends from the precinct boundary
10 north along the center of Shady Grove Road to its intersection with the City of
11 Rockville boundary, then north on the City of Rockville boundary to the precinct
12 boundary;

13 12. That part of election district 9, precinct 6 that is
14 generally the northern part of precinct 6 which extends from the precinct boundary
15 south along the center of the Interstate 270 exit for Fields Road to the center of Fields
16 Road, then east along the center of Fields Road to a point just west of Winners Road,
17 then north staying just west of Winners Road to Washington Boulevard, then along
18 the center of Washington Boulevard to its intersection with Rio Boulevard, then south
19 along the center of Rio Boulevard to its intersection with Fields Road, then west along
20 the center of Fields Road to the intersection at Sam Eig Highway, then continues west
21 to the center of Crown Farm Road, then proceeds west along the center of Crown Farm
22 Road to the intersection of Watch Hill Lane, then along a line just northwest of Crown
23 Farm Road moves north and west to Story Drive and the intersection of County Court,
24 then south along the center of Story Drive to the intersection with Diamondback
25 Drive, then east along the center of Diamondback Drive to the intersection of Sam Eig
26 Highway, then south along the center of Sam Eig Highway to the City of Gaithersburg
27 boundary, then south and west along the City of Gaithersburg boundary to the
28 precinct boundary;

29 13. That part of election district 9, precinct 10 that is
30 generally the western part of precinct 10 which extends from the precinct boundary
31 northwest along the center of B&O Railroad to Washington Grove town limits, then
32 northeast along Washington Grove boundary to its intersection with Ridge Road, then
33 east-northeast along the center of Ridge Road to Amity Drive, then west-northwest
34 along the center of Amity Drive to the precinct boundary;

35 14. That part of election district 9, precinct 20 that is
36 generally the western part of precinct 20 which extends from the precinct boundary
37 east-northeast along the City of Gaithersburg boundary to its intersection with
38 Woodward's Store Road, then northwest along the center of Woodward's Store Road to
39 the precinct boundary; and

40 15. That part of election district 9, precinct 21 that is
41 generally the western part of precinct 21 which extends from the precinct boundary

1 north along the City of Gaithersburg boundary, then west–northwest along the center
2 of Emory Grove Road to the precinct boundary.

3 (v) Board of Education District 2 consists of:

4 1. Election district 2, precinct 4;

5 2. Election district 4, precincts 1, 2, 3, 5, 6, 7, 9, 11, 12,
6 14, 16, 20, 21, 23, 25, 29, 30, and 32;

7 3. Election district 6, precincts 1, 2, 4, 5, 6, and 7;

8 4. Election district 9, precinct 26;

9 5. Election district 10, precincts 1 through 6, 8, 9, 12,
10 and 13;

11 6. Election district 13, precincts 35, 37, 43, 45, 51, 52,
12 and 60;

13 7. That part of election district 2, precinct 2 that is
14 generally the southern part of precinct 2 which extends from the precinct boundary
15 north along a line just east of Clarksburg Road to the shore of Lake Seneca and the
16 precinct boundary;

17 8. That part of election district 4, precinct 15 that is
18 generally the western part of precinct 15 which extends from the precinct boundary
19 and the City of Rockville boundary west to the intersection with the B&O Railroad,
20 then north–northwest along the B&O Railroad to the precinct boundary;

21 9. That part of election district 4, precinct 19 that is
22 generally the western part of precinct 19 which extends from the precinct boundary
23 south along the center of Beach Drive, then south along Park Boundary, then south
24 along the center of Avery Road to the precinct boundary;

25 10. That part of election district 4, precinct 27 that is
26 generally the western part of precinct 27 which extends from the precinct boundary
27 east–northeast along the City of Rockville boundary to its intersection with Twinbrook
28 Parkway, then north–northeast along the center of Twinbrook Parkway to the precinct
29 boundary;

30 11. That part of election district 6, precinct 3 that is
31 generally the center part of precinct 3 which extends from the precinct boundary west
32 along the center of Great Seneca Highway to the precinct boundary, then south along
33 the precinct boundary to its intersection with Great Seneca Creek, then
34 east–southeast along the Great Seneca Creek to the precinct boundary;

1 12. That part of election district 9, precinct 2 that is
2 generally the southern part of precinct 2 which extends from the precinct boundary
3 north along the center of Shady Grove Road to its intersection with the City of
4 Rockville boundary, then north on the City of Rockville boundary to the precinct
5 boundary; and

6 13. That part of election district 9, precinct 6 that is
7 generally the southern part of precinct 6 which extends from the precinct boundary
8 south along the center of the Interstate 270 exit for Fields Road to the center of Fields
9 Road, then east along the center of Fields Road to a point just west of Winners Road,
10 then north staying just west of Winners Road to Washington Boulevard, then along
11 the center of Washington Boulevard to its intersection with Rio Boulevard, then south
12 along the center of Rio Boulevard to its intersection with Fields Road, then west along
13 the center of Fields Road to the intersection at Sam Eig Highway, then continues west

27 4. Election district 13, precincts 3, 7, 16, 26, 27, 34, 38,
28 39, 40, and 62;

29 5. That part of election district 4, precinct 15 that is
30 generally the eastern part of precinct 15 which extends from the precinct boundary
31 and the City of Rockville boundary north–northwest to the intersection with B&O
32 Railroad then east along the B&O Railroad to the precinct boundary;

33 6. That part of election district 4, precinct 27 that is
34 generally the eastern part of precinct 27 which extends from the precinct boundary
35 east–northeast along the City of Rockville boundary to its intersection with Twinbrook
36 Parkway, then north–northeast along the center of Twinbrook Parkway to the precinct
37 boundary; and

1 7. That part of election district 13, precinct 10 that is
2 generally the western part of precinct 10 which extends from the precinct boundary
3 and the county boundary and goes north–northwest along the center of 16th Street to
4 the precinct boundary.

5 (vii) Board of Education District 4 consists of:

6 1. Election district 13, precincts 1, 2, 4, 5, 6, 8, 9, 11

13 along the center of Wintingham Drive to Hawkesbury Lane, then south along the
14 center of Hawkesbury Lane to the precinct boundary;

15 3. That part of election district 13, precinct 10 that is
16 generally the eastern part of precinct 10 which extends from the precinct boundary
17 and the county boundary and goes north–northwest along the center of 16th Street to
18 the precinct boundary;

19 4. That part of election district 13, precinct 49 that is
20 generally the southwestern part of precinct 49 which extends from the precinct
21 boundary north–northeast along the center of Baileys Lane to the precinct boundary;
22 and

23 5. That part of election district 13, precinct 61 that is
24 generally the southwestern part of precinct 61 which extends from the precinct
25 boundary east–southeast along the center of Park Vista Drive to Layhill Road, then
26 south–southwest along the center of Layhill Road to the precinct boundary.

33 (g) (1) The Montgomery County Council may remove a member of the
34 county board for:

- 1 (i) Immorality;
- 2 (ii) Misconduct in office;
- 3 (iii) Incompetency; or
- 4 (iv) Willful neglect of duty.

5 (2) Before removing a member, the County Council shall provide the
6 member a copy of the charges against him and give him an opportunity within 10 days
7 to request a hearing.

8 (3) If the member requests a hearing within the 10-day period:

9 (i) The County Council promptly shall hold a hearing, but a
10 hearing may not be set within 10 days after the County Council sends the member a
11 notice of the hearing; and

12 (ii) The member shall have an opportunity to be heard publicly
13 before the County Council in the member's own defense, in person or by counsel.

14 (4) A member removed under this subsection has the right to a de
15 novo review of the removal by the Circuit Court for Montgomery County.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
17 measure, is necessary for the immediate preservation of the public health or safety,
18 has been passed by a yea and nay vote supported by three-fifths of all the members
19 elected to each of the two Houses of the General Assembly, and shall take effect from
20 the date it is enacted.
