## A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County School Board – Redistricting**

3 FOR the purpose of altering the boundaries of the school board districts for the  
4 election of the members of the Prince George's County Board of Education;  
5 making this Act an emergency measure; and generally relating to the  
6 boundaries of the school board districts for the election of the Prince George's  
7 County Board of Education.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That Section(s) 3–1001 of Article – Education of the Annotated Code of  
20 Maryland be repealed.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
22 read as follows:

21           SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency  
22 measure, is necessary for the immediate preservation of the public health or safety,  
23 has been passed by a ye and nay vote supported by three-fifths of all the members  
24 elected to each of the two Houses of the General Assembly, and shall take effect from  
25 the date it is enacted.
