Rules and Executive Nominations

Prince George's County School Board - Redistricting

This emergency bill redistricts the nine Prince George's County Board of Education districts from which nine school board members are elected.

Fiscal Summary

State Effect: None.

Local Effect: The Prince George's County Board of Elections can make adjustments to board of education districts with existing resources.

Small Business Effect: None.

Analysis

Current Law: Each of the nine elected members of the Prince George's County Board of Education is elected from one of nine school board districts. Each candidate must be a registered voter and a resident of the school board district he or she represents. Board members are elected by the registered voters of each school board district and serve four-year terms, except that the five members with the lowest vote total in the 2010 general election serve two-year terms.

Background: The Prince George's County Board of Education is 1 of 18 elected school boards in Maryland, and 1 of 4 school boards for which some or all board members are elected from local school board districts. There are five appointed school boards in the State, including one (Caroline County) that is in the process of transitioning to a hybrid board of appointed and elected members. Harford County has such a hybrid board. The

selection method and number of school board members for each of the 24 local boards are shown in **Exhibit 1**.
