"<u>BY repealing and reenacting, with amendments,</u> <u>Article – Environment</u>

(3) ANY UNSPENT PORTIONS OF THE FUND MAY NOT BE TRANSFERRED OR REVERT TO THE GENERAL FUND OF THE STATE, BUT SHALL REMAIN IN THE FUND TO BE USED FOR THE PURPOSES SPECIFIED IN THIS ARTICLE.

(4) <u>NO OTHER STATE MONEY MAY BE USED TO SUPPORT THE</u> <u>FUND.</u>

(G) <u>The legislative auditor shall audit the accounts and</u> <u>TRANSACTIONS OF THE FUND AS PROVIDED IN § 2-1220 OF THE STATE</u> <u>GOVERNMENT ARTICLE.</u>".
