AMENDMENTS TO HOUSE BILL 2  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, at the top of the page, strike “EMERGENCY BILL”; in line 4, strike “the construction or remodeling of”; in line 5, strike “to conform to” and substitute “constructed or substantially remodeled in accordance with certain provisions of law to have certain carbon monoxide detectors installed in certain areas; requiring a signal from certain carbon monoxide detectors to be automatically transmitted to a certain location; requiring certain carbon monoxide detectors to be installed in conformance with”; in line 6, strike “for commercial structures” and substitute “or those referenced by the State Fire Prevention Code”; and in line 7, strike “making this Act an emergency measure” and substitute “defining a certain term”.

AMENDMENT NO. 2

On page 1, after line 18, insert:

**“(A) IN THIS SECTION, “SUBSTANTIALLY REMODELED” MEANS ANY ALTERATION OR RESTORATION OF A BUILDING THAT ADDS 50 PERCENT OR MORE SQUARE FOOTAGE TO THE BUILDING AT ANY ONE TIME OR DURING ONE PHASE OF CONSTRUCTION.”;**

and in lines 19 and 22, strike “(a)” and “(b)”, respectively, and substitute “**(B)**” and “**(C)**”, respectively.

AMENDMENT NO. 3

On page 1, in line 22, strike the brackets; in the same line, strike the colon.

On page 2, in line 1, strike “**(I) ALL**”; strike beginning with the semicolon in line 2 down through “**STRUCTURES**” in line 5; after line 9, insert:

(Over)

“(D) (1) (I) A BUILDING TO BE CONSTRUCTED OR SUBSTANTIALLY REMODELED UNDER THIS SECTION SHALL BE REQUIRED TO INSTALL APPROVED CARBON MONOXIDE DETECTORS IN AREAS OF NEW AND EXISTING EDUCATIONAL OCCUPANCIES WHERE FUEL FIRED EQUIPMENT IS PRESENT.

(II) A SIGNAL FROM A CARBON MONOXIDE DETECTOR INSTALLED UNDER THIS SUBSECTION SHALL BE AUTOMATICALLY TRANSMITTED TO AN APPROVED SUPERVISING STATION OR TO A CONSTANTLY ATTENDED ON-SITE LOCATION.

(2) THE CARBON MONOXIDE DETECTORS REQUIRED UNDER THIS SUBSECTION SHALL BE INSTALLED IN ACCORDANCE WITH THE NATIONAL FIRE PROTECTION ASSOCIATION 720: STANDARD FOR THE INSTALLATION OF CARBON MONOXIDE (CO) DETECTION AND WARNING EQUIPMENT, 2009 EDITION OR AS REFERENCED IN THE STATE FIRE PREVENTION CODE.”;

and strike beginning with “is” in line 10 down through “enacted” in line 14 and substitute “shall take effect October 1, 2012”.
