AMENDMENT NO. 1

On page 1, in line 19, after "review" insert ", approve, or require the revision of"; strike beginning with "authorizing" in line 19 down through "plan;" in line 20; in line 22, after "final;" insert "requiring the Department to post a certain final plan on the Department's Web site within a certain period of time after approving the plan;".

On page 2, in line 6, strike "requiring" and substitute "<u>authorizing</u>"; and in line 7, after "terms;" insert "providing for the construction of this Act;".

AMENDMENT NO. 2

On page 7, in line 24, strike "IN REGULATION".

On page 8, in line 7, strike "PROCESSING" and substitute "RECYCLING"; after line 15, insert:

"(IV) LISTS THE METHODS THE MANUFACTURER WILL USE TO RECYCLE THE PLASTIC CARRYOUT BAGS THAT IT COLLECTS;";

and in lines 16 and 19, strike "(IV)" and "(V)", respectively, and substitute "(V)" and "(VI)", respectively.

On page 9, in line 1, before "PLAN" insert "<u>DRAFT</u>"; in line 3, strike "AND"; in line 4, after "EACH" insert "<u>DRAFT</u>"; in line 5, after "SECTION" insert "; AND

(4) (I) APPROVE THE DRAFT PLAN; OR

(II) REQUIRE REVISION OF THE DRAFT PLAN";

strike beginning with "THE" in line 6 down through "(E)" in line 8; in lines 10, 11, 22, and 26 in each instance, before "PLAN" insert "<u>DRAFT</u>"; in line 16, strike "APPLICABLE" and substitute "<u>REQUIRED BY THE DEPARTMENT</u>"; strike beginning with "POSTING" in line 17 down through "SITE" in line 18, and substitute "<u>REVIEW</u>"; in line 19, strike "(F)" and substitute "(E) (1)"; in lines 21 and 23, strike "(1)" and "(2)", respectively, and substitute "(I) 1." and "2.", respectively; and in line 26, after "DEPARTMENT" insert "; AND

- (II) AFTER THE DEPARTMENT HAS APPROVED THE DRAFT PLAN.
- (2) THE DEPARTMENT SHALL POST THE FINAL PLAN ON THE DEPARTMENT'S WEB SITE WITHIN 30 DAYS AFTER APPROVING THE PLAN".

AMENDMENT NO. 3

On page 11, in line 14, strike "AND PROCESSING"; in the same line, after "LOCATIONS," insert "RECYCLING METHODS,"; and in line 18, strike "PROCESSED FOR RECYCLING" and substitute "RECYCLED".

AMENDMENT NO. 4

On page 12, in line 11, strike "**APRIL 1, 2015,**" and substitute "**OCTOBER 1, 2013,**"; in line 28, strike "**\$100**" and substitute "**\$500**"; in line 29, strike "**\$250**" and substitute "**\$1,000**"; and in line 30, strike "**\$500**" and substitute "**\$1,500**".

On page 13, in line 9, strike "SHALL" and substitute "MAY"; after line 10, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be construed to prohibit a retailer from recycling plastic carryout bags in the same

in line 11, strike "2." and substitute "3."; and in line 20, strike "3." and substitute "4.".
