AMENDMENTS TO HOUSE BILL 395
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 15, strike “Board” and substitute “Department of Health and Mental Hygiene, in consultation with the Department of Budget and Management,”; in line 16, after the first “certain” insert “management and”; and in the same line, after “date;” insert “requiring the Department of Health and Mental Hygiene and the Department of Budget and Management jointly to develop specifications for a certain solicitation; requiring the Department of Budget and Management to oversee a certain independent entity; requiring that the costs of a certain study be paid from the Board of Nursing Fund; requiring the Department of Budget and Management, on or before a certain date, to report to certain committees of the General Assembly on the results of a certain study;”.

AMENDMENT NO. 2

On page 6, in line 6, after “(a)” insert “(1)”; in the same line, strike “State Board of Nursing” and substitute “Department of Health and Mental Hygiene, in consultation with the Department of Budget and Management,”; in line 7, after “a” insert “management and”; in the same line, strike “to determine the necessity and allocation of additional staff”; after line 7, insert:

“(2) The Department of Health and Mental Hygiene and the Department of Budget and Management jointly shall develop the specifications for the solicitation of the contract required under paragraph (1) of this subsection.

(3) (i) The Department of Budget and Management shall oversee the independent entity that is performing the management and personnel study required under paragraph (1) of this subsection.

(Over)

(ii) The independent entity that is performing the management and personnel study required under paragraph (1) of this subsection shall report directly to the Department of Budget and Management regarding the study.

(4) The costs of the management and personnel study required under paragraph (1) of this subsection shall be paid from the Board of Nursing Fund established under § 8-206 of the Health Occupations Article.”;

in line 9, strike “(i) 1.” and substitute “(1)”; in line 11, strike “2.” and substitute “(2)”; in the same line, after “minimum” insert “;

(i)”;

in line 12, strike the comma and substitute “;

(ii)”;

in line 13, strike the comma and substitute a semicolon; in the same line, after “and” insert “(iii)”; in line 15, strike “(ii)” and substitute “(3)”; in lines 16 and 17, strike “1.” and “2.”, respectively, and substitute “(i)” and “(ii)”, respectively; in line 18, strike “(iii)” and substitute “(4)”; and after line 21, insert:

“(d) On or before December 1, 2013, the Department of Budget and Management shall report to the Senate Education, Health, and Environmental Affairs Committee and the House Health and Government Operations Committee, in accordance with § 2-1246 of the State Government Article, on the results of the management and personnel study required under subsection (a) of this section.”.
