AMENDMENTS TO HOUSE BILL 757

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “Children” in line 2 down through “Area” in line 3 and substitute “Domicile Requirements for Attendance - Exception”; strike beginning with “authorizing” in line 4 down through “factors;” in line 8; strike beginning with “in” in line 9 down through “domiciled” in line 10; in line 11, after “Resources” insert “and the Secretary of Juvenile Services each”; and in line 12, after “children;” insert “requiring the State Department of Education to adopt certain regulations to implement certain provisions of a certain federal law;”; in line 13, strike “in State-supervised care”; in line 14, strike “whether the child resides in the geographical area of the school” and substitute “the domicile requirements for attendance at that school”; and in line 17, strike “4-109 and”.

AMENDMENT NO. 2

On pages 1 and 2, strike beginning with line 23 on page 1 through line 18 on page 2, inclusive.

AMENDMENT NO. 3

On page 2, in line 30, strike “**ANY SCHOOL IN THE COUNTY THAT THE CHILD HAS BEEN**” and substitute “**THE SCHOOL THAT THE CHILD IS**”; and strike beginning with “**IN**” in line 31 down through “**AND**” in line 32 and substitute “**WHO IS:**”

A. IN THE CUSTODY OF, COMMITTED TO, OR OTHERWISE PLACED BY A LOCAL DEPARTMENT OF SOCIAL SERVICES OR THE DEPARTMENT OF JUVENILE SERVICES; AND

B. SUBJECT TO THE EDUCATIONAL STABILITY PROVISIONS OF THE FEDERAL FOSTERING CONNECTIONS TO SUCCESS AND INCREASING ADOPTIONS ACT OF 2008;

2. THE CHILD IS NOT SUBJECT TO THE EDUCATIONAL STABILITY PROVISIONS OF THE FEDERAL MCKINNEY-VENTO HOMELESS ASSISTANCE ACT AS A CHILD AWAITING FOSTER CARE PLACEMENT AS DEFINED BY THE DEPARTMENT IN REGULATION;

3. THE CHILD IS NOT IN ANY OF THE FOLLOWING PLACEMENTS:

A. A DETENTION FACILITY;

B. A FORESTRY CAMP;

C. A TRAINING SCHOOL;

D. A STATE-OWNED AND STATE-OPERATED FACILITY THAT ACCOMMODATES MORE THAN 25 CHILDREN; OR

E. ANY OTHER FACILITY OPERATED PRIMARILY FOR THE DETENTION OF CHILDREN WHO ARE DETERMINED TO BE DELINQUENT;”.

On page 3, in line 1, strike “2.” and substitute “4.”; strike beginning with the comma in line 1 down through “HYGIENE,” in line 2; in line 3, after “DETERMINES” insert “, IN CONSULTATION WITH THE LOCAL SCHOOL SYSTEM,”; in line 4, after “SCHOOL” insert “; AND”

5. THE LOCAL DEPARTMENT OF SOCIAL SERVICES OR THE DEPARTMENT OF JUVENILE SERVICES PAYS FOR THE COST OF TRANSPORTING THE CHILD TO AND FROM SCHOOL;

in line 5, after “(III)” insert “1.”; in the same line, strike “SECRETARY” and substitute “DEPARTMENT”; in the same line, after “RESOURCES” insert “AND THE DEPARTMENT OF JUVENILE SERVICES EACH”; strike beginning with “IN” in line 7 down through “PARAGRAPH” in line 8 and substitute “UNDER THIS SECTION”; and after line 8, insert:

“2. THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THE EDUCATIONAL STABILITY PROVISIONS OF THE FEDERAL FOSTERING CONNECTIONS TO SUCCESS AND INCREASING ADOPTIONS ACT OF 2008.”.
