## AMENDMENT NO. 1

On page 1, in line 2, strike "Elected School"; in the same line, after "Board" insert "of Education – Selection of Members"; in lines 3 and 18, in each instance, after "election" insert "and appointment"; in line 5, after the first "of" insert "all"; in the same line, after "Education;" insert "establishing the composition of the county board; providing for the qualifications, terms of office, and the filling of a vacancy of certain members of the county board;"; strike beginning with "establishing" in line 7 down through "members;" in line 8; in line 8, after "elected" insert "or appointed"; in line 9, after "terms;" insert "providing for a student member of the county board; providing for the term and duties of the student member;"; in line 10, after "of" insert ", and hearings and appeal procedures for, certain"; in the same line, strike "under certain circumstances" and substitute "of the county board"; strike beginning with "providing" in line 10 down through "board;" in line 11; and strike beginning with "providing" in line 13 down through "Commission;" in line 16.

#### AMENDMENT NO. 2

On page 2, strike line 9 in its entirety; in lines 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, and 24, in each instance, strike the brackets; and in lines 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, and 24, strike "(3)", "(4)", "(5)", "(6)", "(7)", "(8)", "(9)", "(10)", "(11)", "(12)", "(13)", "(14)", "(15)", "(16)", and "(17)", respectively.

On page 3, in lines 1 and 2, in each instance, strike the brackets; in lines 1 and 2, strike "(18)" and "(19)", respectively; after line 2, insert:

"(B) IN BALTIMORE COUNTY, IN ACCORDANCE WITH SUBTITLE 2A OF THIS TITLE, THE MEMBERS OF THE COUNTY BOARD SHALL BE A COMBINATION OF MEMBERS WHO ARE ELECTED AND APPOINTED.";

and in lines 3, 6, 9, and 16, strike "(b)", "(c)", "(d)", and "(e)", respectively, and substitute "(C)", "(D)", "(E)", and "(F)", respectively.

## AMENDMENT NO. 3

On page 3, in line 21, strike "NINE" and substitute "SIX"; in the same line, after "NONPARTISAN" insert "ELECTED"; strike beginning with "ELECTED" in line 21 down through "AND" in line 22 and substitute a semicolon; after line 22, insert:

# "(2) FIVE APPOINTED MEMBERS; AND";

in line 23, strike "(2)" and substitute "(3)"; in the same line, strike "FROM THE COUNTY AT LARGE"; in line 24, strike "THE NINE" and substitute "OF THE ELEVEN"; in the same line, after "ELECTED" insert "AND APPOINTED"; strike beginning with "SHALL" in line 24 down through "(2)" in line 26 and substitute "OF THE COUNTY BOARD:

(II) FIVE MEMBERS SHALL BE APPOINTED BY THE GOVERNOR":

- "(2) (I) THE SIX ELECTED MEMBERS SHALL BE ELECTED AT A GENERAL ELECTION IN ACCORDANCE WITH § 3-2A-02 OF THIS SUBTITLE.
- (II) THE FIVE APPOINTED MEMBERS SHALL BE APPOINTED, WHEN APPROPRIATE, WITHIN 90 DAYS AFTER THE GENERAL ELECTION.".

## AMENDMENT NO. 4

On page 4, in line 8, after "ELECTED" insert "OR APPOINTED"; after line 13, insert:

- "(C) (1) FOLLOWING EACH DECENNIAL CENSUS OF THE UNITED STATES, THE COUNTY COUNCIL OF BALTIMORE COUNTY IN CONSULTATION WITH THE COUNTY BOARD, AND AFTER REASONABLE OPPORTUNITY FOR PUBLIC REVIEW AND COMMENT, SHALL ESTABLISH THE SCHOOL BOARD DISTRICTS IN THE COUNTY.
- (2) EACH SCHOOL BOARD DISTRICT SHALL BE SUBSTANTIALLY EQUAL IN POPULATION.
- (3) REAPPORTIONED SCHOOL BOARD DISTRICTS SHALL BECOME EFFECTIVE FOR THE TERM OF OFFICE THAT BEGINS AFTER THE FIRST REGULAR PRIMARY ELECTION THAT IS HELD AT LEAST 15 MONTHS AFTER THE OFFICIAL REPORT ON POPULATION IS RECEIVED BY THE STATE FROM THE BUREAU OF THE CENSUS.";

in line 15, after the second "THE" insert "<u>ELECTED MEMBERS OF THE</u>"; in line 28, strike "EACH ELECTED" and substitute "<u>EXCEPT FOR THE STUDENT MEMBER, A</u>"; in line 30, after "ELECTION" insert "OR APPOINTMENT"; in the same line, after

"ELECTED" insert "OR APPOINTED"; and in line 33, after "ELECTED" insert "OR APPOINTED".

# AMENDMENT NO. 5

On page 5, in line 1, after "ELECTED" insert "OR APPOINTED".

On page 6, in line 9, strike "ELECTED" and substitute "<u>NONSTUDENT</u>"; in lines 10 and 12, in each instance, strike "\$3,000" and substitute "<u>\$100</u>"; in line 19, after "A" insert "<u>NONSTUDENT</u>"; and in line 27, after "ELECTED" insert "<u>OR APPOINTED</u>".

On page 7, in line 2, after "ELECTED" insert "OR APPOINTED".

On pages 7 through 9, strike in their entirety the lines beginning with line 28 on page 7 through line 16 on page 9, inclusive.

On page 9, in line 17, strike "3-2A-10." and substitute "3-2A-09.".

#### AMENDMENT NO. 6

On page 12, in lines 6 and 7, strike "on November 30, 2014" and substitute "<u>as</u> follows:

- (a) The term of the one member appointed from councilmanic district 5 of Baltimore County whose term is scheduled to expire on June 30, 2013, shall terminate at the end of June 30, 2013, and the Governor shall appoint an additional member to the county board, as authorized under this Act, who shall succeed the member whose term terminated and serve for a term of 1 year, 5 months, and 7 days, until a successor is appointed and qualifies; and
- (b) The terms of the six members appointed from councilmanic districts 1, 2, 3, 4, 6, and 7 of Baltimore County, or their successors, who are in office on the effective date of this Act, shall terminate at the end of December 7, 2014, and the members

elected from the school board districts 1, 2, 3, 4, 5, and 6 in Baltimore County, as established in accordance with this Act, at the general election in November 2014, shall succeed those appointed members and serve for a term of 4 years beginning on December 8, 2014, until a successor is elected and qualifies.

SECTION 3. AND BE IT FURTHER ENACTED, That, in appointing members to the Baltimore County Board of Education, the Governor shall ensure, to the extent practicable, that the total makeup of the county board reflects gender, ethnic, and racial diversity";

and in line 8, strike "3." and substitute "4.".
