AMENDMENTS TO SENATE BILL 928  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “services” in line 5 down through “plan” in line 6 and substitute “an administrative service”; strike beginning with “and” in line 6 down through “employer” in line 7; and in line 13, after “Commissioner;” insert “defining certain terms;”.

AMENDMENT NO. 2

On page 2, in line 7, after “(1)” insert:

**“(I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE MEANING INDICATED.**

**“(II) “ADMINISTRATIVE SERVICE” MEANS A SERVICE, OTHER THAN A SERVICE RELATED TO THE SALE, SOLICITATION, NEGOTIATION, OR SERVICING OF A HEALTH BENEFIT PLAN, THAT AN INSURANCE PRODUCER PROVIDES TO ASSIST AN EMPLOYER IN:**

**1. COMPLYING WITH A STATUTORY OR REGULATORY REQUIREMENT;**

**2. PROVIDING AN EMPLOYEE BENEFIT ON BEHALF OF THE EMPLOYER; OR**

**3. PERFORMING FUNCTIONS RELATED TO THE MANAGEMENT OF EMPLOYEES OF THE EMPLOYER.**

**(III) "HEALTH BENEFIT PLAN" HAS THE MEANING STATED  
IN § 2-112.2 OF THIS ARTICLE.**

strike beginning with "SERVICES" in line 10 down through "1." in line 12 and substitute "AN ADMINISTRATIVE SERVICE THAT"; strike beginning with the semicolon in line 13 down through "EMPLOYER" in line 15; in line 18, strike "SIMILAR" and substitute "OTHER COMPENSATION"; in line 19, strike "REMUNERATION"; in lines 19 and 20, strike "FOR THE SALE OF" and substitute ", NONPROFIT HEALTH SERVICE PLAN, OR HEALTH MAINTENANCE ORGANIZATION RELATED TO"; in line 20, strike "TO" and substitute "OF"; in line 24, strike "**(2)**" and substitute "**(3)**"; in line 25, strike "APPROVED" and substitute "ADOPTED"; in the same line, after "COMMISSIONER" insert "BY REGULATION"; and in lines 27 and 28 and 29 and 30, in each instance, strike "OR GROUP OF ADMINISTRATIVE SERVICES".

On page 3, in line 1, after "(III)" insert "IF THE INSURANCE PRODUCER SELLS A HEALTH BENEFIT PLAN TO THE EMPLOYER,"; in the same line, strike "SIMILAR" and substitute "OTHER"; in line 2, strike the second "THE" and substitute "AN"; in line 3, after "INSURER" insert ", NONPROFIT HEALTH SERVICE PLAN, OR HEALTH MAINTENANCE ORGANIZATION"; in the same line, strike "FOR THE SALE OF THE HEALTH BENEFIT PLAN TO THE EMPLOYER" and substitute "RELATED TO THE HEALTH BENEFIT PLAN"; in line 4, strike "**(3)**" and substitute "**(4)**"; and in the same line, strike "**(2)**" and substitute "**(3)**".
