AMENDMENT NO. 1

On page 1, in line 4, after "language;" insert "repealing provisions of law that establish bonus antlered deer stamps;"; strike beginning with "nonresident" in line 6 down through "stamps" in line 7 and substitute "bonus deer stamp"; in line 9, after "nonresident" insert "hunting and"; strike beginning with "establishing" in line 10 down through "stamps;" in line 11; strike beginning with "providing" in line 11 down through "Act;" in line 12 and substitute "requiring the Department to work with certain organizations to identify certain funding mechanisms on or before a certain date;"; and in line 27, after "10-308(b)" insert "and 10-503".

On page 2, strike in their entirety lines 3 through 8, inclusive.

AMENDMENT NO. 2

On page 2, in line 31, strike "antlered".

On page 3, in line 33, strike "A TURKEY STAMP,".

On page 4, in line 14, strike "NONRESIDENT"; and after line 18, insert:

"(III) A JUNIOR HUNTING LICENSE FOR AN INDIVIDUAL UNDER THE AGE OF 16 YEARS THAT ENABLES THE LICENSEE TO HUNT AND TRAP ALL LEGAL GAME BIRDS AND MAMMALS NOT EXCEPTED BY THE DEPARTMENT IN REGULATION, DURING ANY APPROPRIATE SEASON IN MARYLAND, WITHOUT THE PURCHASE OF AN ADDITIONAL LICENSE OR STAMP."

On page 5, in line 8, strike "\$9.00" and substitute "**\$12.00**"; strike in their entirety lines 9 and 10; in line 11, in each instance, strike the bracket; in the same

line, strike "(VII) Resident bonus antlered" and substitute "**BONUS**"; in the same line, strike "\$10.00" and substitute "**\$25.00**"; and strike in their entirety lines 12 through 15, inclusive.

On page 6, after line 21, insert:

"10-308.1.

(b) (1) A person may obtain a Maryland migratory game bird stamp for [a] THE fee [of \$9.00] ESTABLISHED IN § 10-301 OF THIS SUBTITLE from any person designated by the Department. The issuing person designated shall retain the sum of 75 cents as compensation for issuing each stamp. The balance of the fee is paid over and accounted for to the State Treasurer. The Treasurer shall credit all such fees received to the State Wildlife Management and Protection Fund, in accordance with § 10-209 of this title."

On page 8, after line 22, insert:

"[10-503.

A nonresident of the State may not hunt or trap or attempt to hunt or trap any beaver or otter in the State.]".

On pages 8 through 11, strike in their entirety the lines beginning with line 23 on page 8 through line 18 on page 11, inclusive.

On page 11, in line 19, strike "3." and substitute "2."; strike beginning with "Section" in line 19 down through "2013" in line 20 and substitute "the Department shall consult with the Wildlife Advisory Commission, the Maryland Legislative Sportsmen's Foundation, and other interested organizations to identify additional funding mechanisms for wildlife management in Maryland before December 31, 2012";

in line 21, strike "4." and substitute "<u>3.</u>"; and strike beginning with ", except" in line 21 down through "Act," in line 22.
